

**MINUTES  
SENIORS COMMISSION  
TOWNSHIP OF MONROE  
JUNE 7, 2012**

The Regular Meeting of the Monroe Township Seniors Commission was called to order by Chairperson Jeanette Remsen at 7:07PM in the 2<sup>nd</sup> Floor Meeting Room of the Municipal Complex. Notice of this meeting was given as required by the annual notice of meetings.

Chairperson Jeanette Remsen led the Commission in the salute to our flag.

**ROLL CALL**

The Monroe Township Seniors Commission did not have a quorum for the June meeting. No official business was held.

**APPROVAL OF MINUTES**

Due to a lack of quorum, there was no voting of minutes.

**CORRESPONDENCE, REPORTS AND OTHER MATTERS**

The members in attendance reviewed the May meeting minutes and spoke in reference to the booked trips. Chairperson Jeanette Remsen mentioned that only 28 people have signed up for June 14<sup>th</sup>'s trip, 'They're Playing Our Song'. The flyer for July 14<sup>th</sup>'s trip for the Brooklyn Tour is being distributed the following day after the meeting. For July 19<sup>th</sup>'s trip, 'Jonah', 37 people have paid so far, with a possibility of 4 more people. August 4<sup>th</sup>'s trip, 'The Great American Songbook 3', will be advertised after the July trip. Pat Cooper for September 21<sup>st</sup> has not yet been advertised. 'I Love You, You're Perfect, Now Change!' will be October 13<sup>th</sup> and 'The 2012 Christmas Show' will be December 1<sup>st</sup>.

Jeanette said that she would like to meet with Kevin Heydel, B.A. and Cncl. Dilks in reference to the Seniors Commission Budget; only \$5,600.00 was budgeted for 2012 for the Commission. The Commission cannot hold a trip every month with \$5,600.00. Jeanette noted that the January and April trips did not cost the township, because the trips were to the Casino in Atlantic City.

Jeanette confirmed that the Blood Drive will be held August 6, 2012 2:30pm-7:30pm at the Pfeiffer Community Center.

Mentioned at the May meeting, 106 different people were serviced during the January thru April trips; Jeanette said that after the May trip, a total of 121 different people were serviced between the 5 trips in 2012, including 66 new people attending these trips between January and May.

A trip for November has not yet been decided on. Mel said that she received information in the mail about a Christmas show in Atlantic City. Since the Commission is short in budget monies, they may take another Casino trip, because it won't cost the township. The members in attendance reviewed the budget and determined that the Commission needs \$2,425.00 for the remainder of the 2012 trips.

**CORRESPONDENCE, REPORTS AND OTHER MATTERS** (cont'd)

Jeanette said that she hopes that they can fill the Brooklyn Tour trip. She and Mel mentioned that there will be little walking that will need to be done on the trip and that there will be a step-on guide.

Jeanette asked if anyone had any ideas/suggestions.

Secretary Aileen notified the members that she will not be in attendance of the October meeting.

**ADJOURNMENT**

With no further business to discuss, Chairperson Jeanette Remsen asked for a motion to adjourn. Mel O'Connell made a motion to adjourn the Monroe Township Seniors Commission Meeting of June 7, 2012. The motion was seconded by Mary Chiodo; all in favor. Meeting adjourned at 7:50pm.
