Cncl. Walter Bryson reported attending along with the Mayor and Cncl. Sebastian the homecoming celebration of Army Specialist Derrick Eidem on Thursday, December 22nd at Images Photography Studio. The homecoming celebration was a surprise for Derrick as well as his mother. Cncl. Bryson spoke of the trials and tribulations the country has been going through over the last four years and expressed his wishes for all levels of government to work together to bring jobs to the United States and to work with existing businesses to keep them here. He noted this year the township has begun to see some economic improvements that will hopefully create jobs for our residents and he extended his appreciation to Council for all the work they did to bring the new shopping centers here. He also extended his appreciation to Cncl. Pres., Dilks for doing an excellent job this year despite the personal hardship he went through. Cncl. Bryson also extended wishes to everyone for a happy, healthy and prosperous New Year.

Cncl. Frank Caligiuri reported attending the Gloucester County Improvement Authority Meeting on December 15th where the GCIA 2012 budget was discussed. He gave the authority a lot of credit for taking a conscientious view of that budget as it is very challenging due to cuts, concessions and having to justify the way funds will be divvied up according to new state laws. Cncl. Caligiuri reported attending the Environmental Commission Meeting on December 19th and also extended his appreciation to Cncl. Pres., Dilks for doing an excellent job while going through some of the most challenging conditions that life has to offer.

Cncl. Rich DiLucia reported attending a Veterans Committee Meeting in Holiday City that was well attended by veterans from World War II and the Vietnam Conflict. The Gloucester County Director of Veterans Affairs gave a detailed presentation regarding veteran

benefits. He opened the meeting for questions and discussions as there were veterans in attendance that were not aware of some of the benefits they are eligible for. One veteran advised the group that the Monroe Township MUA gives a 10% reduction on water and sewer Cncl. DiLucia noted any veterans watching the Council Meeting on TV who would like bills. information about veteran benefits should contact the Gloucester County Veterans Affairs Office to schedule an appointment to meet with a member of their staff. Cncl. DiLucia spoke of receiving phone calls regarding checks in the amount of \$400.00 to \$500.00 that were received by seniors and disabled people. They thought the checks replaced the homestead rebate that Cncl. DiLucia explained they are not checks, it is was previously in the amount of \$1,250.00. actually a receipt that should be taken to the Tax Office during the February tax quarter and the Cncl. DiLucia spoke of amount on the receipt will be subtracted from that quarter tax bill. legislation passed recently that requires State and municipal employees to pay up to 30% towards their health insurance. That cost is phased in over a four year period. Recently the judges, who also receive compensation for providing a service, challenged the law saying judges should be immune to the law because State Statute does not allow a judge's salary to be cut. Cncl. DiLucia felt that State Statute was established to prevent compensation from being taken away by the political process punishing judges because of how they ruled. Instead of the judge, who also benefits from that State Statute recusing herself, she ruled in favor of the judges saying that in fact they were protected under this law and did not have to pay towards their health insurance. He noted in this instance the judicial system ruled for themselves contrary to what everyone else has to do. He felt there may be some legal challenges to the entire issue and he wondered whether the judges will also rule that under collective bargaining agreements wages cannot be cut. Cncl. DiLucia extended best wishes for a happy, health New Year. He also commended Cncl. Pres., Dilks for doing a tremendous job as council president in a year that was really difficult for him.

Cncl. William Sebastian reported attending the Derrick Eidem welcome home ceremony and noted what was unique about it was the fact that his mother did not know that he was home. In most cases the mother and family plan a coming home celebration for the soldier but in this particular case it was the soldier and his brother that planned the surprise for his mother. It was a unique surprise and it went over very well as there were approximately 100 people in attendance. Cncl. Sebastian noted he hoped everyone had a happy and blessed Christmas and he wished everyone a happy and healthy New Year.

Cncl. Daniel Teefy commended Cncl. Pres., Dilks for a job well done and he wished everyone a happy, healthy New Year.

Mayor Michael Gabbianelli spoke of the welcome home celebration for Army Specialist Derrick Eidem being attended by many dignitaries and how the mother figured it out when she saw all the people. The Mayor thanked the residents for supporting the food pantry and the Williamstown Fire Company Christmas tree sale. He also extended best wishes for a happy and healthy New Year and noted his wish for 2012 is for the economy to turn the corner.

Cncl. Pres., Marvin Dilks expressed his appreciation to the Clerk and her staff for the work they did this year providing Council with all the information they needed to do their work. He also expressed his appreciation to all members of Council for their kind words and for stepping up to help him during the months he was caring for his wife. He also extended New Year wishes to everyone.
