**AUGUST 19, 2013**

APPROVAL OF MINUTES

Christine Feggans made a motion to approve the minutes as submitted of the Economic Development Commission Meeting of July 15, 2013. The motion was seconded by Jared Valdez and approved by all

members of the Commission in attendance.

**CORRESPONDENCE, REPORTS AND OTHER MATTERS** 

Cncl. Sebastian brought examples of district maps that he had picked up from Aileen Wojciechowski,

since she was unable to attend the meeting. They have business ads around the perimeter of the map and

then business locations marked on the map. Jill Simmermon asked if a physical map was something that

people would still have an interest in and questioned how they would be dispursed. Cncl. Sebastian and

Tony Langella said they still use physical maps along with a GPS. Manny Bermudez mentioned versions

of the maps that had more of a cartoon feel to depict businesses. Jared Valdez is going to bring in an

example to September's meeting to compare.

Cncl. Sebastian also provided all members with a copy of the 2013 budget. He explained how an

encumberment works. If an invoice is received for the cost of the sign(s) in 2013, the monies encumbered

this year in the 2013 budget will stay until next year and get paid from the 2013 budget. Since there are

still signs that need to be purchased but not enough funds to make the entire purchase, the funds can be

encumbered and used with funds from next year to pay for the new signs.

Cncl. Sebastian also reported that he is still waiting on a report from Kevin about the tax card program.

Kevin wants to speak with municipalities that are currently using the card program.

Cncl. Sebastion said that Applebee's has still not found a location to suit their needs.

Manny came to the meeting to possibly take an open seat. He told us that he manages the Fulton Bank in

Monroe, he has been at that location for 2 years, before that he was at the branch in Winslow for 3 years

and has been in banking for 9 years. Tony asked if the banks are lending money for new businesses,

Manny confirmed that they are lending money to businesses there are just not as many exceptions as there

were previously. Jared asked why he wanted to join the commission and Manny said that he would like to

be part of something that is going to do the town good.

Tony asked if everyone was satisfied with the locations of the signs and if there are any other locations

that could use a sign. Jill suggested that a sign be put in coming into Monroe from Franklinville on

Tuckahoe Road. Manny suggested signs that would direct people to either businesses or historical sites.

Tony is going to talk to Jason about pricing for another sign.

Jared explained the tax card program to Manny, he got the contact information to contact Fincredit. He

asked how Fincredit received the funds from the businesses. He was going to check to see if there was a

way that the bank could run the same program.

Everyone was asked to bring in contact information for 3 businesses that they would like in town. Cncl.

Sebastian said that he would like to see a seafood restaurant, a Mexican restaurant and a Chuck E.

Cheese. Jared suggested Red Lobster, Dave and Busters and Speedway, which is an indoor go cart

facility. Christine suggested a medical products store, Michael's, Disney store, Nike, Sony entertainment,

furniture store, Nintendo(arcade), Red Baron, hoover round scooter. Tony suggested an urgent care and

something for the kids, there aren't enough facilities for the kids in the town. Manny was asked for

suggestions and said restaurants.
