First Reading: A copy of this ordinance was posted on the bulletin board at the Municipal Complex. Additional copies were made available to the public.

Cncl. DiLucia made a motion to approve Ordinance O:07-2014 for First Reading and Publication. The motion was seconded by Cncl. Pres., Garbowski and unanimously approved by all members of Council in attendance.

E.) REPORTS AND OTHER MATTERS

Cncl. Bryson reported attending the Cheerleading competition at Rowan University and congratulated the teams from St. Mary's who won 1st Place in the competition that included teams from South Jersey and Pennsylvania. He reported Parks and Recreation has scheduled their annual Easter Egg Hunt at the Pfeiffer Center on Saturday, April 12th and the Music Festival on Saturday, June 7th. The Music Festival will include live bands, many vendors and a Home Run Derby sponsored by the All Pro Baseball and Softball Academy. On May 17th from 9:00 AM to 3:00 PM the Historical Society is holding their first annual British Car Show featuring cars from the British Motor Club of South Jersey, members of the Historical Society dressed in old English attire, a tea garden, flea market and an open house at the Ireland House. Cncl. Bryson reported Girl Scout Troop 63553 is working on a project to create a dog park in the Township. He invited Scout leader Amanda DeVault to the podium to read letters submitted by 5th grade students from Williamstown Middle School, which gave reasons why a dog park should be created. The scouts are working on this project to earn a bronze award and have generated the letters as well as a petition in favor of a dog park.

Cncl. Caligiuri reported attending the Williamstown Middle School Environmental Educational Summit on March 12th, the Open Space Committee Meeting on March 6th and the Planning Board Meeting on February 27th where a minor subdivision was approved.

Cncl. DiLucia reported attending the School Board Meeting on Thursday, March 6th where discussion took place regarding the budget. He noted one item brought up gave an example of waste, as they will be required to place \$1.2 million into their budget to prepare for the new testing procedure the federal government is mandating. He spoke of Bill Cowher, former head coach of the Pittsburg Steelers promoting the "Heads Up Program" a national initiative to make football safer. The program through the NFL involves grant money that will be distributed to youth organizations and high schools throughout the Country to educate coaches in ways to protect players from injury.

E.) REPORTS AND OTHER MATTERS (cont'd)

Cncl. Sebastian reported attending the Zoning Board Meeting on March 18th at which time a variance was granted for a shed. He also spoke of creating a dog park and read into the record an article from the March 24th edition of the Courier Post regarding Evesham Township holding a public hearing to get input from residents on a proposed dog park. The article stated the township would apply for grants, sponsorships and even sell memorial bricks to limit the cost to taxpayers. Evesham Township already applied to the Department of Environmental Protection for a change on Green Acres parkland to allow the dog park to be located in Savich Field, an open space preservation area. The DEP advised they did not need DEP approval on that, as that decision could be made by the township.

Cncl. Teefy reported ARH is working with the Girl Scout Troop leader to select a location for the dog park and he commended the Public Works Department for the great job they did removing the snow. Cncl. Teefy also reported Monroe Township received a Sustainable Jersey Grant in the amount of \$2,000.00 to assist the community Green Teams as they lead and coordinate the sustainability activities in the community. Additional information about the grant is on the township website.

Mayor Gabbianelli reported the 2014 municipal budget was presented to the taxpayers at the March 10th Council Meeting. He noted he was proud of the accomplishments made by his administration, as the budget is the result of years of proper planning, hard work and it represents the priorities and promises of this Administration, to provide top rate services to our residents. This year the municipal budget was presented with a 1.7% increase, below the 2% CAP mandated by the State and we expect the overall tax rate to increase up to 4.9% as we work with the Gloucester County Tax Assessor's Office to stabilize our tax base. Last year about 50% of our residents experienced a significant increase due to the impact of a Compliance Plan aimed at stabilizing our tax base. The other 50% experienced a decrease in taxes. This year we expect the opposite effect on our residents. Those residents who experienced a significant decrease last year or had their taxes decreased through the tax appeal process, should receive an increase this year while those who had the increase last year, will see a decrease this year. It has been a long road, guiding our township through the economic recession and collapse of the housing market over the past 5 years. However, we weathered the storm. The tax base has been stabilized and things are clearer for the future. The Mayor noted this is his last budget address and he thanked the residents for allowing him to serve as their mayor.

Cncl. Pres., Garbowski reported attending the Economic Development Commission Meeting on March 17th. The EDC is working in conjunction with the Williamstown High School Audio Visual Club to put together a video to advertise the fine points of Monroe Township to future businesses. The committee also discussed the Welcome to Monroe Township signs that the Public Works Department is installing at the entrances to the township on Winslow Road, Fries Mill Road, Coles Mill Road, Clayton Road and Malaga Road. He also reported attending the Library Board Meeting on March 19th at which time the Board discussed sending out RFP's for a coffee and tea service and "Library Dinner Night" at the Library IV Restaurant on May 18th. That night the restaurant will donate a portion of the cost of each dinner to the Monroe Township Public Library. Cncl. Pres., Garbowski also mentioned that Resolution R:76-2014 was adopted to initiate the "Buy Monroe" tax program.

F.) GENERAL PUBLIC DISCUSSION

Cncl. DiLucia made a motion to open the General Public Discussion. The motion was seconded by **Cncl. Bryson** and unanimously approved by all members of Council in attendance.

Chris Cugini, 1814 Watercress Court, spoke of Mary Cote addressing Council at the Work Session Meeting and of how Mayor Gabbianelli called her an idiot. Mr. Cugini noted Mary works tirelessly for the community and the Mayor should not call her or any other resident an idiot. Mr. Cugini noted he will address this issue with Mayor.
