**A.) OPENING CEREMONIES**

The Reorganization Meeting of the Council of the Township of Monroe was called to order by **Township Clerk, Susan McCormick** at 6:00 PM in the Council Chambers of the Municipal Complex as 125 Virginia Avenue, Williamstown, New Jersey.

This meeting was advertised pursuant to the New Jersey Open Public Meetings Act (N.J.S.A. 10:4-6 thru 10:4-21). Notices were placed in the official publications for Monroe Township (i.e: South Jersey Times Times, the Courier Post and the Sentinel of Gloucester County). A copy of that notice was posted on the bulletin board at the Municipal Complex.

**Cncl. Walter Bryson** lead the Assembly in the Pledge of Allegiance to Our Flag and **Betsy Eley, Council President of St. John's Lutheran Church** offered the Invocation.

**B.) SWEARING IN CEREMONY**

**Township Clerk, Susan McCormick** welcomed everyone to the Reorganization Meeting and Swearing in Ceremony for the year 2015.

Cncl. Miller was asked to take his seat at the podium.

**Cncl. DiLucia** noted he had a question to direct to the Solicitor regarding the resolution appointing a member to the Monroe Municipal Utilities Authority that was inadvertently removed from the agenda. He questioned whether that could be reinstituted on the agenda as there are a number of people from the MMUA in attendance to see that appointment made tonight. **Solicitor Fiore** noted historically during his tenure as Solicitor the MMUA appointment has been at the Reorganization Meeting but legally the five year term of the MMUA member does

not expire until January 31, 2015. It is the prerogative of Council to put it back on the agenda this evening and a motion can be made to do that but if other Council members do not want to move it forward someone can make a motion to table it. He noted the Clerk informed him two minutes prior to the meeting that normally the Council President sets the agenda however Mr. Garbowski was not available to do that. **Cncl. DiLucia** noted it then should have reverted to him as Council Vice-President but whether the vote is held tonight or a month from now is not important however, it would be abnormal to hold it a month from now. There has been ample time to review all the qualifications of the people who applied for this position and this appointment is the only opportunity Council has to have any say in the MMUA. There are seven Councilmen here tonight, which would avoid a tie in the event only six members attend the next meeting so unless there is strong opposition in making that appointment tonight he would like to ask his fellow Council members to allow it to be put back on the agenda. He added he would like to see it done because he does not understand why it was removed. **Solicitor Fiore** explained that would require a motion and a roll call vote of all the members of Council. **Cncl. DiLucia** questioned whether it would be appropriate to do that now. He explained the reason he raised the issue now is because the public portion will be the next agenda matter after the election of Council President and Vice-President. He questioned when the appropriate time would be to make that motion. **Solicitor Fiore** advised after the new Council President is sworn into office.

The motion was seconded by **Cncl. Caligiuri** and unanimously approved by all members of Council

Cncl. Miller made a motion to accept the Mayor's appointments. The motion was seconded by Cncl. Dilks.

Cncl. Bryson questioned if the Faulkner Act allows for the appointment of a Deputy Mayor and if so what are his duties and responsibilities. Solicitor Fiore explained the Faulkner Act is silent about the position of Deputy Mayor. If silent it is permitted and that position has never been challenged in the past. The Faulkner Act does not preclude the Township from

creating that position via ordinance and that was done in the past. The position falls under Chapter 4-54 of the Monroe Township Code and is referred to as Assistant to the Mayor serving for a period of one year or until a successor qualifies. Cncl. Bryson explained he questioned it because he has not seen it in the past and didn't see it included in the Faulkner Act. Mr. Fiore noted Mayor Gabbianelli appointed Ed Derrickson as Deputy Mayor but when Ed passed away that position was never filled. The Deputy Mayor does not have all the powers of the mayor but can assist in services the Mayor would provide as an elected official. He can't act as the Mayor but can act on behalf of the Mayor. Cncl. Bryson noted the Faulkner Act has a succession of duties and he questioned whether the Deputy Mayor's succession would be after the Mayor or after President of Council. Mr. Fiore noted he does not have any of the Mayor's powers, he acts on the Mayor's behalf for ceremonial purposes and may ascertain information but does not have the power of the Mayor.

**J.) MAYOR'S COMMENTS**

Mayor Daniel Teefy noted it is an honor to be Mayor of Monroe Township but it is something he never thought about thirty years ago when he volunteered to coach kids in basketball. He just wanted to be a coach to help kids but then one night when he didn't show up for a meeting they elected him president of the Basketball League because they felt at 28 years old he could take the Basketball League to another level and that did happen by working with the schools. As the years went by people told him he should be more involved so he did that by becoming a councilman. Then people told him he should run for mayor because he could take the town to the next level and that is why he chose to run. He added he is proud to be the Mayor and he thanked everyone for their faith and confidence in him. He noted his uncle told him that God gave him two ears and one mouth and he should use them wisely to listen to people. He noted he is going to listen to his employees, the Council members, the Clerk's Office and the Administration to guide him in the right way and will be approachable for everyone because he cannot do this alone and needs people to help him along the way. He will work to have a good relationship with County and State officials to work together to make positive changes. Good people will be around him and he will give them the tools, the authority and responsibility to make decisions. He added we can accomplish a lot in four years and he is looking forward to this. He thanked Betsy Eley for doing the invocation, the people in the audience and the people watching the meeting on TV for supporting him and congratulated Cncl. McIlvaine, Miller and Heffner for a job well done and Campaign Manager Carol LaCore for her guidance during the campaign. He noted he was wearing a pocket watch from his daughter Lauren, cufflinks with a picture of his daughter Tiffany and him and a money clip his son Daniel gave to him when he was in kindergarten. Mayor Teefy also displayed the gift his daughter Madison gave him on Father's Day, which was a name plate that said "Mayor Daniel P. Teefy, Monroe Township" and thanked his wife Linda for her support, love and guidance. He noted changes begin tonight starting with the Marvin Wagner Field located on the pike in Cecil. Many things have been tried at that park but nothing has worked out. Marvin Wagner was a former councilman who was a youth football and baseball coach who was killed in a car accident in the early 1980's. He coached at the Church Street fields so tonight the Church Street Baseball Field will be renamed the Marvin C. Wagner Church Street Field. We will then see if the field in Cecil can be used by local schools,

colleges and the Environmental Commission for farming and horticultural things. If that property can be farmed it could help the Food Bank feed the community. Mayor Teefy noted he will open up a township Facebook page as a way to communicate to our residents and information will be put out on a weekly/daily basis so people know what is going on. He noted we still fax in the township so we are going to work with the employees to get rid of those fax machines by scanning and emailing. Trash pickup will be done differently. We are looking at placing trash cans on one side of the street in development areas, as that will save time, gas and wear and tear on the vehicles. Employees will be able to pick up the trash quicker, which will improve services. He spoke of how new people are submitting Citizen Leadership forms and he urged people to keep submitting those forms to get involved with the boards and commissions. In previous years people were just put on the boards without having any qualifications but now people submit forms/resumes with their information so people are put on the right boards. Mayor Teefy noted he is looking for positive changes such as this and is looking forward to working with the police and fire departments, as public safety is very important. He noted within the first thirty days he will put together a Main Street Committee that will start making improvements to Main Street. He urged residents to email him at [mayor@monroetownshipnj.org](mailto:mayor@monroetownshipnj.org) with any suggestions they may have as communication is very important. Once the township has email addresses residents can be updated on township services, such as when leave pickup will be done in their neighborhoods. The township will also have a Facebook page where residents will be able to ask questions and we are looking into getting a Twitter account as well. He spoke of how he was bothered for a week about a small section of the Christmas lights on the Hofer House being out. He noted that is a small thing but someone needs to pay attention to those things because residents notice little details like that. He added the Christmas decorations will be taken down shortly, we won't have to wait until July this year because now we have a bucket truck to do it ourselves. He noted he is looking forward to working with Council and wants to continue communicating with them like Mayor Gabbianelli did. He also expressed his appreciation to all the residents of Monroe for their support.

**K.) COUNCIL COMMENTS**

**Cncl. Bryson** thanked Senate President Steven Sweeney, Senator Fred Madden, Congressman Donald Norcross, Assemblyman Moriarty and Assemblywoman Mosquera and the audience for attending the meeting and participating in the ceremonies this evening. He also thanked those watching the meeting on television and wished everyone a happy, healthy and productive New Year. Cncl. Bryson noted as we move forward from this ceremony to become the 2015 governing body he wanted the new Mayor and Councilmen to know that he will work with them to do all he can to help make Monroe Township a better place to live and work for all of residents.

**Cncl. Dilks** noted it will be an honor and he is looking forward to working with the new members of Council and the new Mayor in 2015. He added this is his eleventh year on Council and he has only served with one mayor so this will be different.

**Cncl. DiLucia** noted this is his seventh Reorganization Meeting and this year holds for us very challenging things. The papers say things are turning around and the economy is getting better; maybe on Wall Street, but not for the everyday working people. He added it poses challenges for them and challenges that require leaders with solutions and as many of us who were athletes know, if there is a break in the chain of a team there will be no victories. Cncl. DiLucia noted he will pledge to pull his load as a team member and do everything he can to form a strong bond to go forward and do what is right for the residents of Monroe Township who we have sworn to serve. He extended best wishes for a happy, healthy and prosperous New Year.

**Cncl. Heffner** extended appreciation to Mayor Gabbianelli, Cncl. Garbowski and Cncl. Sebastian for all their years of service to the township and extended best wishes in all their future endeavors. He noted it is amazing to be sitting here as a Council member and expressed his appreciation to everyone for their support. Cncl. Heffner promised to work very hard for the people of this township and noted he looks forward to working with everyone on Council.

**Cncl. McIlvaine** extended his appreciation to everyone for having faith and believing in them to do this job. He promised to work extremely hard as a team player and noted when he


