Jeanette is waiting on a price for an overnight stay for September 11<sup>th</sup>-12<sup>th</sup> to Foxwood & Mohegan Sun Casinos. She would also like to book another trip for September, beside the overnight trip. A trip will be held on December 3<sup>rd</sup>; the December Seniors Commission meeting will be rescheduled. Jeanette mentioned that 'Inspire' is showing at American Music Theatre and asked the members if they thought people would be interested in this show. The members discussed dates and chose October 9<sup>th</sup>. The members discussed dates to see 'Social Security' at Hunterdon Hills Playhouse; they chose September 19<sup>th</sup>, possibly eating at Fulton Steamboat. The members discussed going to Mt. Airy. There are seniors who feel that it's too long of a ride, approximately 5 hours round-trip. They would like to maybe visit on November 10<sup>th</sup>.
