E.) REPORTS AND OTHER MATTERS

Cncl. Bryson reported May 9<sup>th</sup> will be a very busy day in Williamstown and two events that day are being sponsored by the Historical Society, the 2<sup>nd</sup> Annual British Car Show and the Hall Street School Re-Opening Ceremonies. The car show will be held between 10:00 AM and 3:00 PM at the Ireland House. This event features the South Jersey British Car Club, a tea garden, food, crafters and a disc jockey playing British invasion songs. The Historical Society would like to make this a yearly event that gets bigger each year by expanding to Marquis - Triumphs of South Jersey and also Jaguars. The Hall Street School Re-opening will be held during the same time period. A lot of work was recently completed on the school, which is probably the only kindergarten/first grade school in the USA with an Alumni Association. He noted the school will need a new roof but that will be done in the future. He encouraged everyone to come to these events as well as the Historical Society meetings held on the first Thursday of the month at 7:00 PM, as there is a lot to learn about the town.

Cncl. DiLucia reported the Open Space Committee Meeting was to be held on Easter Monday but he was the only one who showed up because he forgot the meeting had been rescheduled to April 13<sup>th</sup> and that night he had a Council Meeting that took precedence so he could not attend. Cncl. DiLucia suggested residents take notice when they come to the municipal building to pay their taxes that the floors and walls have been thoroughly cleaned. He commended the Business Administrator for hiring the cleaning company; noting they did a really good job, it looks like a new building. Cncl. DiLucia noted he is honored to have been asked by the president of the Holiday City Veteran's Association to be the guest speaker at their annual Memorial Day Celebration. He noted he attends this event every year and is really looking forward to this as it is a pleasure to be asked by this great group of veterans. He reported the Sunday Philadelphia Inquirer had a political article about the city's candidates for mayor but the crux of the article was that the issue the candidates should be addressing is the one about pensions. The article stated the pension fund is in terrible shape and on the brink of bankruptcy only being funded by 45%, which is a terrible amount for a pension fund. The reason he is raising this is because he has been speaking about his concerns regarding the New Jersey Pension Fund. Time and time again he has stated that the employees and the municipality have made their contributions to both the Police/Firemen and the Public Employee's Pension Funds and that is a big number. He again implored the governor to make the State contributions to those plans, as the court has directed him to do. Right now the stock market is performing fairly well keeping them afloat but if that takes a dip, it will have a really negative impact on those pensions, which are teetering.

Cncl. Heffner reported attending the annual Easter Egg Hunt on March 28<sup>th</sup> held by the Parks and Recreation Commission. He commended the Commission for doing a great job putting out 8,500 eggs, which it took all of three minutes for the kids to find. The weather was not the best but it was still a nice event. April 4<sup>th</sup> was Opening Day Ceremonies for Monroe Township Little League. It was their 63<sup>rd</sup> year and in the twenty-two years he has been involved in little league this was the first year he got to throw out the first pitch. The weather was not the best on that day either but the kids still had a good time. He reported attending the Zoning Board Meeting on April 7<sup>th</sup>. Not much going on with that Board so slow the April 21<sup>st</sup> meeting has been cancelled. Cncl. Heffner extended appreciation to Jackie Wallace for running the Clean Communities Program, which gets organizations together to clean up the township.

Cncl. McIlvaine reported attending the Economic Development Commission Meeting. The Commission discussed banners for Main Street, which will be up by the middle of May

along with flags for the Memorial Day Parade. Flags have not been up for the past several years for the parade and the Commission wants that changed and the light poles and flag poles along Main Street painted prior to the parade. He reported attending a dedication for the freezer donated by the Rotary Club to the Pfeiffer Center food pantry and commended Jackie Wallace for the work she did on Saturday organizing the cleanup with various organizations throughout the County. He reported the Library Board Meeting was cancelled so he had no report from that committee.

Cncl. Miller reported he did not have the privilege to attend the Municipal Alliance Commission Meeting on the first Monday of the month but has been kept informed of the progress and what they are seeking to do. He urged everyone to keep a lookout for their signs/banners for their 2<sup>nd</sup> Annual Drug Reality Forum. This is a forum where people can come to discuss the needs and concerns of the community especially pertaining to substance abuse and to let people know there are avenues and resources out there that provide support and assistance to help individuals. He extended his appreciation to the Municipal Alliance Commission and Chairman Michelle Perez, who is actively trying to do more. Monroe Township is doing its part to combat this issue and has had the highest number of saves with Narcan in Gloucester County. He reported he had the honor of attending the County Economic Development Commission Meeting for the municipalities. Discussion took place regarding small businesses. Redevelopment will be a future topic and an interesting thing about Gloucester County is that it is picking up in tourism and wineries that are popping up. Hopefully a winery will be interested in coming to Monroe Township because we have plenty of land for one. He noted in those meetings he is surrounded by leaders from all the different communities in Gloucester County and will bring back to Council any information he learns.

Mayor Teefy noted Cncl. Bryson asked him to let everyone know that all British type cars are invited to participate in the Historical Society British Car Show. The Mayor thanked the Sunshine Rotary Club for donating the freezer to the food pantry and also the workers that participated in the Clean Communities event on Saturday. He noted he wanted to thank Jackie Wallace for doing a great job organizing this event and the Deputy Mayor Andy Potopchuk for filling in for him there. The Municipal Alliance also held a program at the Middle School and the Deputy Mayor attended that as well. The Mayor reported he was the guest speaker on Thursday, April 16<sup>th</sup> at the Blue Prayer Service held at Our Lady of Peace Church. The service was very well attended and the local school students did a great job putting banners together for the Police Department, Williamstown Fire, Cecil Fire, Monroe EMS and County EMS. The Mayor noted the police and some EMTs are paid but others and the fire departments are volunteers that take time away from their families to serve the community and we appreciate that. Thursday, April 23<sup>rd</sup> was "Take Your Children To Work Day" and the kids had a great time learning what their parents and grandparents do. The children learned the Mayor eats Tootsie Rolls and colors because that's what was available for the kids to do in his office that day. Future mayors had a great time taking pictures in his office and some even put their feet up on his the desk. The Mayor reported a company called Clean As A Whistle did a fantastic job cleaning the municipal building and now our maintenance staff can just maintain the building. Kevin Heydel had sent an email to all employees asking them to clear their desk and the owner of the company said that made their job much easier. The Mayor added it means a lot to our employees to come into a clean building. Mayor Teefy requested when residents have landscaping materials (mulch, stones, etc.) delivered to their homes that the materials be dropped in their driveways. At times that is not possible so if it is placed on the street residents have 48 hours to remove the materials. He noted the streets need to be cleared as soon as possible for the mail and trash trucks. **Director of Public Safety, Jim Smart** advised a notice went out to all local businesses that dumping in the street is not allowed. This policy has been in place for the last two years because those materials in the street contaminate the water runoff and affects traffic as well. The Mayor reported during the month of April potholes were filled and Winslow Road was milled and repaired. Leaf collection will begin on May 4<sup>th</sup> and will run through May 29<sup>th</sup>. Residents can check the township website and Facebook page for the leaf collection schedule and if there are any delays in the schedule. At the last Council Meeting the Cooper Employee Assist Program was approved and supervisor training will begin on May 14<sup>th</sup> to help supervisors recognize problems employees may have. Mayor Teefy reported the township has been addressing issues at the Country Motel but the situation has improved as the cesspools have been pumped at least twice a week. The

motel owner has been out of town but should be back tomorrow so hopefully this issue will be resolved. The Mayor urged people to come out to the Memorial Day Parade on Monday, May 25<sup>th</sup> to honor our veterans. He also encouraged residents to attend the Michael Dobleman 3 on 3 Scholarship Basketball Tournament on Saturday, May 9<sup>th</sup> at Williamstown High School. Registration is from 9:00 AM to 10:00 AM and games begin at 10:00 AM. He reported the Music Festival will be held on Saturday, June 6<sup>th</sup> at 5:00 PM to 10:30 PM at Owens Park. This event includes three stages with The FM Band as well as three other bands playing the main stage, bands will also be playing the other stages, there will be vendors, food and fireworks at 10:00 PM.

**Engineer, Chris Rehmann** reported the contract was awarded for last year's Winslow Road grant and we are waiting for an additional grant this year so the Road Department will not need to go out and mill that road again, it will be taken care of with the new construction. We have submitted an application to the County for a \$50,000.00 Community Development Block Grant for Poplar Avenue handicap ramps and sidewalk improvements. Kevin has worked hard over the last five years to get a good contact there and we have been successful in getting an additional \$300,000.00 in CDBG grant money and hopefully we will add another \$50,000.00 this year. He noted Cncl. DiLucia had questioned the status of the Dog Park on the Genova recreation fields. At this point we have asked for a Green Aces grant but unfortunately it takes anywhere from seven to nine months to receive a decision on that. His office called Green Acres today and was told their decision would be coming shortly but that could mean another month so his office will keep on top of this to make sure it keeps moving. He reported the County has advised him that the Cecil Fire Department fuel facility is located where they want to put up the cell tower so it must be moved. Unfortunately, that fuel facility is a tank on skids and while it can be moved it has no leak protection so we will be coming back to council with a cost to make that all self-contained so it meets code requirements. Council questioned the size of the tank and if it could be pumped out and moved. Mr. Rehmann replied it's not more than 550 gallons. The tank is in good condition and can be pumped but the problem is there is no leak protection and it is not double walled. Mr. Rehmann reported on May 8<sup>th</sup> a meeting will be held with the participants of the Fries Mill Road/Glassboro Road intersection. The mayor is pushing that group and we have gotten the consulting engineer who is doing the work for the developers to respond. If he finishes the plans it would be in the best interest of the township because if not the township would need to pay him (*Mr. Rehmann*) to finish those plans and he doesn't want to do that unless he absolutely has to. **Cncl. Bryson** noted that intersection has been a priority for quite some time. The County has been talking about widening Route 322 and he felt that would be a good place to start rather than on the western side of 322. Mr. Rehmann indicated it was not the County, that intersection and the link to Glassboro is included in the Department of Transportation's ten year old Master Plan but that project is sitting on the back burner as the DOT infrastructure trust fund is running out of money. He reported the Mayor held a conference call with the County engineer's office and their position is that they have no jurisdictional authority in that intersection including portions of Fries Mill Road but they did not say they would back away from the project. The comment was get the plans approved and then we can go together to DOT to see how much of this we can get funded. Mr. Rehmann noted he was looking at cooperation from the County and that is a good portion of what is needed. Moving the power line poles on Fries Mill Road is the biggest problem, as that may cost \$300,000.00 so that issue needs to be addressed and hopefully the design engineer is taking that into consideration. Another issue becoming frustrating to him and Mr. Fiore is Amberleigh's bonding company has not responded so he will not be able to get the trees planted, the landscaping fixed and the other necessary work completed. He noted frankly at this point he doesn't know what to do except say we will not accept another bond from that company. This is an issue because the same thing is happening in Willow Woods. Mannington Drive was paved by a contractor that did a terrible job and Richmond America Homes has been told not to pay them for that work because we will not accept it. Jersey Construction Company is the contractor but they subcontracted the job and we told them they have to take it up and do it again. Mr. Rehmann noted he explained to the homeowners that this will take time, as it may involve a bond. Richmond is disagreeing with us and Jersey Construction said they would do minor milling and repaving and we are saying no that is not acceptable. Richmond America is aware of certain sections that are not draining properly and have agreed to fix those areas but have not agreed to repave Mannington Drive yet. Mr. Rehmann noted the Mayor is aware of this and he wanted Council know this matter may take some time and they may have to put up with some complaints from the residents. When

complaints are received he suggest Council say, if they agree, that they are aware of the problem and told Richmond not to pay for the work because it is unacceptable. Mr. Rehmann went on to say the problem is he only has a contractual relationship with the developer who hired these people; he has no relationship with the contractor who we may have difficulties with their qualifications. He noted he is not sure whether that could be regulated through legislation but his thought is, if it was, in the future we could get the right contractors because you can't do a road the size of Mannington Drive with someone whose expertise is driveways. Mr. Rehmann noted he has no authority, other than just telling the developer if they want to pave with someone that doesn't have the right equipment that's their business but the township will not accept poor quality work. Mayor Teefy noted we will keep pushing them from our end because that road is not acceptable. He also noted in regards to the May 8<sup>th</sup> meeting the County has been very acceptable in talking and working with us regarding the Fries Mill Road/Rt. 322 intersection and hopefully at the meeting we will see some progress. He noted during his conference call with the County he stated west of Glassboro, Logan Township and the by-pass have been taken care of but east where we are has not and they should not forget us. He added he is trying to drive that message home to them. Mr. Rehmann noted at one time there was a proposal for a hotel at the Scotland Run intersection and Gerry White, from the County indicated they would be happy to share their economic development person to find ways of helping the Scotland Run people build something out there so we are talking to Chip Ottinger to see if we can get him back on that path. Cncl. Bryson noted Rowan is expanding and there is only one or two motels for out of town parents visiting their children to stay in so a new hotel at the Scotland Run location would be a real asset for Glassboro and Monroe.

**Director of Code Enforcement, George Reitz** reported the owner of the Country Motel on Corkery Lane did get the easement to connect to the municipal sewer and that work should be completed within the next month. He also reported the unregistered car and boat/trailer on Forest Drive have been removed and along with the Director of Public Safety he is working on getting the two unregistered vehicles on Red Oak removed. Mayor Teefy thanked Mr. Reitz for taking care of these issues.

**Director of Public Safety, Jim Smart** reported EMS has been asked to be at the ARC's annual 5K Run and Walkathon on May 9<sup>th</sup>. The run will begin at Camp Sun and Fun and take place on the shoulder of Tuckahoe Road from Camp Sun and Fun to the traffic light at Clayton Road and back. He also reported the Police Department did an excellent job posting signs and advising people at Amberleigh that they could no longer park on the streets. He noted he was there Sunday and only one car was on the street. All the parking areas were full and people are parking in their driveways so it seems to be working out.

The Environmental Commission has expressed interest in giving some input into the Master Plan especially with the Environmental Resource Inventory and the Natural Resource Inventory and there was also some discussion about backyard chicken farms. H noted he is looking into this to learn from the mistakes of other communities before making a recommendation to council.

**Mayor Teefy** noted Williamstown High School baseball team had a big win over Washington Township. The score was 4 to 3 and their record is now 9 and 1.

F.) GENERAL PUBLIC DISCUSSION




