One at 11:00AM for the Bearded Guitar Repair at 206 S. Main Street and another at the Williamstown Art Center at 382 S. Main Street at 1:00PM. He reminded all the Memorial Day Parade starts at 11:00AM along Main Street from St. Mary's to the Veteran's Memorial. A service will be conducted at the memorial and at the conclusion everyone is invited back to the American Legion and the VFW.

# F.) REPORTS AND OTHER MATTERS (cont'd)

Mayor Teefy extended his thanks to the Deputy Mayor who stepped in for him at a Veteran's Event that took place at Holiday City. This past Thursday was another drug forum, initially at the first forum there were approximately 25 people in attendance and over 200 attended the latest one. There was a 30 minute movie presented entitled "If Only" and he felt every kid and every parent should view this movie as it is very enlightening. He reported on a feature story being done by Anderson Cooper of CNN, who will be conducting a town hall meeting relating to the prescription drug/opiate initiative. A representative (Amanda Potopchuk) from our Municipal Alliance was asked to attend and represent us at that meeting, she may also be selected to have her questions answered and be part of the discussion. The mayor reported on the Arts Festival held on Saturday, April 30th. He extended his thanks to the Main Street Committee for their efforts with a turnout of approximately 700 people. Mayor Teefy reported on the plans for the Memorial Day Parade that will be held on Monday, May 30th at 11:00AM he urged everyone to come out in support of our veterans. Mayor Teefy extended his thanks to council members for their support of the 2016 budget, he also recognized Business Administrator, Kevin Heydel for an excellent job on his work on the budget. He felt it was a good, solid budget with the lowest increase since 2004 and it will provide good structure and stabilization for our town.

**Director of Public Safety, Jim Smart** reported the Office of Emergency Management conducted an "*Incident Action Plan*" in conjunction with the Arts Festival. He added OEM with a new year and new group has been performing well for the town. He reported on the ARC run which took place on Saturday, May 7<sup>th</sup> with somewhere in the area of 130 participants.

Cncl. Pres., Miller echoed the mayor's comments with regard to the Main Street Committee and expressed his thanks to the committee for all their work. He spoke on the budget process and that he appreciated how open the administration has been in answering questions and how both the mayor and business administrator always have an open door. The budget, this year, represents what is trying to be accomplished in the township while also being fiscally responsible as represented by the lowest increase since 2004.
