He referred to the correspondence Council received regarding the B & B litigation and noted he thought a conference call with Judge Curio would be held prior to this meeting to discuss the legal ramifications of the case but that did not occur. It has been rescheduled for one day next week so it will be more productive to report on this matter at the next Council Meeting in closed session. In regards to the Summerfields West affordable housing the committee met with the developer's attorney who was supposed to have the draft settlement agreement to him prior to this meeting but that has not been received so that matter will also be addressed at the next Council Meeting in closed session.

#### MAYOR APPOINTMENT

**Mayor Teefy** appointed **Christina Unipan** to the Alternate # 1 position and **Rebecca Budney** to the Alternate # 2 position on the Economic Development Commission.

#### MAYOR APPOINTMENT cont'd)

**Cncl. Heffner** made a motion to approve the Mayor's appointments to the Economic Development Commission. The motion was seconded by **Cncl. Caligiuri** and unanimously approved by all members of Council in attendance.

**Mayor Teefy** appointed **Charlene Maycott** to the unexpired term ending December 31, 2018 and **Katrina Blong** to the vacant position expiring December 31, 2017 on the Municipal Alliance Commission.

**Cncl. DiLucia** made a motion to approve the Mayor's appointments to the Municipal Alliance Commission. The motion was seconded by **Cncl. Dilks** and unanimously approved by all members of Council in attendance.

**Mayor Teefy** administered the Oath of Office to **Katrina Blong** as a member of the Monroe Township Municipal Alliance Commission.

#### D.) ORDINANCES

**Cncl. Pres.**, **Miller** turned this portion of the meeting over to **Ordinance Committee Chairman**, **Cncl. Heffner**. **Cncl. Pres.**, **Miller** made a motion to open the meeting to the public for anyone wishing to speak regarding the ordinances listed for First Reading. The motion was seconded by **Cncl. Caligiuri** and unanimously approved by all members of Council in attendance.

**Director of Public Safety Jim Smart** questioned why Ordinance O:35-2016 was needed since there is a double yellow line along the pike that makes it illegal to make a left hand turn. **Solicitor Fiore** explained there was an attempt by the Police Department to issue a local violation with a monetary penalty rather than giving a person making a left turn from the pike into Walmart a violation that would give them penalties and surcharges through Motor Vehicles. The State sent a letter indicating our ordinance was preempted by State Statute. Now people will get a ticket for an improper turn and under State Statute they will get points and surcharges. The bottom line is under local ordinance the State gets no money from fines but under State Statute they get half the fine. **Cncl. Heffner** questioned whether this also includes a left hand turn into Peter's Diner. Mr. Fiore replied no because that has not been brought to the attention of the State at this point in time. Mr. Fiore went on to explain the Ordinance refers to three different left hand turns from the pike. One into Forest Hills, one into Peter's Diner and then the one into the Walmart and the only one being rescinded at this time is the one at the Walmart. The local ordinance gives the police a tool to cite people without them getting points or surcharges.

With no one else wishing to speak Cncl. Pres., Miller made a motion to close the Public Portion. The motion was seconded by Cncl. Caligiuri and unanimously approved by all members of Council in attendance.

**Cncl. Pres.**, **Miller** made a motion to approve Ordinance O:36-2016. The motion was seconded by **Cncl. DiLucia** and unanimously approved by all members of Council in attendance.

#### E.) <u>REPORTS AND OTHER MATTERS</u>

**Cncl. Heffner** had no report but commented that Whitehall Road (*recently paved*) looks fantastic.

**Mayor Teefy** commended Kathryn Cornforth and Mike Calvello for pointing out that Whitehall Road definitely needed to be repaved and thanked everyone who attended the Veteran's Day Ceremonies on Friday night. He reported that he would be attending a luncheon at the League of Municipalities to pick up an award for Sustainable Jersey and that he attended Veteran's Day Ceremonies at Holiday City on November 5<sup>th</sup> with a number of Council members and the Deputy Mayor. He noted that ceremony was very moving due to the stories of a veteran.

**Kathryn Cornforth** reported while there is still no word on the status of the NJDOT approval for Rt. 322 and Fries Mill Road her office has moved forward and contacted the utility companies and a meeting was held with Verizon and Atlantic City Electric to get a ballpark of what it will cost to move all the lines. The next step is to get South Jersey Gas to confirm that they don't need anything and then we will meet with the MMUA.

**Director of Public Works, Mike Calvello** reported Whitehall Road has been milled and overlaid from the Black Horse Pike to Lakeside Drive and that has resolved many of the problems on the bridge area. The road has been completed and now we are getting prices for stripping.

**Director of Community Development, Rosemary Flaherty** thanked Scott White and all those who attended on Saturday and helped put the food baskets together from The Holiday Food Drive for the needy. She also thanked the veterans for raising money from a hoagie sale on Saturday.

**Cncl. Pres., Miller** thanked the Mayor, Main Street Chairman Ernie Carbone and Rosemary Flaherty for the work they did for the "*Grow With Williamstown Tour*", which was a success. Many people got to see the township and there was a nice article in the Courier that focused on numbers that will show businesses that they should come grow with us.

#### F.) GENERAL PUBLIC DISCUSSION

**Cncl. Heffner** made a motion to open the General Public Discussion. The motion was seconded by **Cncl. DiLucia** and unanimously approved by all members of Council in attendance.

**William Blong** noted he recently ran for Council and from the political pack of "*The Friends of DeFelice and Blong and Monroe Republicans for Working Families*" he had two checks to donate to the township one for the Monroe Township K-9 Foundation and one for the Monroe Township Municipal Alliance. Council thanked Mr. Blong for the donations.

With no one else wishing to speak **Cncl. Heffner** made a motion to close the General Public Discussion. The motion was seconded by **Cncl. Dilks** and unanimously approved by all members of Council in attendance.
