

**MINUTES

**APPROVAL OF MINUTES**

Corine Stark made a motion to approve the minutes as submitted of the Seniors Commission Meeting of November 3, 2016. The motion was seconded by Veronica Kwasniewski and approved by all members of the Commission in attendance; abstain by Nancy Lorraine, who was not in attendance of the November meeting.

**CORRESPONDENCE, REPORTS AND OTHER MATTERS**

Chairperson Jeanette Remsen confirmed that the Seniors Commission Reorganization Meeting will be Thursday, January 5, 2017.

Jeanette noted that the American Red Cross Blood Drive that the Commission is hosting will be Friday, February 17, 2017.

Jeanette said that she will let everyone know when she speaks with Academy of Culinary Arts of Atlantic Cape Community College to see when they can book a trip there for dinner at Careme's Restaurant. Jeanette asked the Commission if they think it's too far to go to Mount Airy Casino Resort. The bus ride would be 2 ½ hours, with a total of 5 hours of riding on the bus in one day and traveling back home in the dark. The members think it's too far of a trip to take. Jeanette spoke with Tomasello Winery for their brunch/lunch/casino trip. She asked the members about whether to go to an Atlantic City casino or to Philadelphia. The members reviewed and discussed trip fliers that Jeanette provided them with. Jeanette booked 'My Mother's Italian, My Father's Jewish, I'm STILL in Therapy!' for June 28, 2017. Frankie Avalon is booked for September 26, 2017 at Ceasars Casino in Atlantic City. Jeanette said that people are asking her about booking the Christmas show at Sight & Sound Theater. She said that American Music's 2017 Christmas Show is tentatively booked for Tuesday, December 5, 2017. She thinks that American Music's shows have been disappointing. She asked the members how they felt about booking Sight & Sound's Christmas show, that maybe they can book them for November and American Music for December. The members suggested canceling American Music and going for Sight & Sound instead.

The members discussed dates to book the show for a day within December 4<sup>th</sup>-7<sup>th</sup>. The members discussed seeing 'Clue', in Bucks County, in May. She would like for it to clearly state that the bus will be leaving on time and if someone can't make the trip, they're to call Jeanette to let her know. The members discussed seeing Patsy Cline at Pines Dinner Theatre on October 18, 2017. Jeanette will also try to book 'Momma Won't Fly' at Rainbow's Comedy Playhouse for February 8, 2017; 'Legends of Pop' at Hunterdon Hills Playhouse for March 2, 2017; 'Miracle of Christmas' at Sight & Sound Theatre for December 7, 2017 or a day between December 4<sup>th</sup>-7<sup>th</sup>. There will be no trip booked for January 2017.
