### ROLL CALL

### APPROVAL OF MINUTES

Len asked if there was any talk of the Master Plan being re-evaluated and Cncl. DiLucia said that he is not aware of any. Jerry asked the status of the dog park, and Cncl. DiLucia said that they have applied for a grant with Green Acres. He said the park will be located by Owen's Park off Clayton Rd, also known as the Genova Property.

Planning Board: Zoning Board: Len had nothing to report related to Open Space.

### OPEN DISCUSSION

There was a discussion about the farm near the airport that is harvesting hops, as well as the potential for the microbrewery on Main Street. Cncl. DiLucia also brought up that he read prior to the meeting that there is a new proposed bill to allow restaurants (not chains) without a bar or liquor license to serve alcohol.
