E.) REPORTS AND OTHER MATTERS

Mayor Teefy reported that he attended the 30th anniversary celebration of Juniper Village Assisted Living. He said there was also a grand opening for IM Dance Academy located in Trader's Lane and a grand opening for Lenny's Shoe & Leather Repair located on South Main Street. He mentioned there is a grand opening scheduled on April 13, 2018 for 13th Child Brewery.

Engineer Kathryn Cornforth informed Council that this was the last meeting she would be attending for the Township before her Maternity Leave and will return for the Council Meeting in August.

Dir. of Public Works, Mike Calvello reported there will be a Community Shred Event at the Free Public Library on Marsha Avenue on April 22, 2018 from 9am-12pm.

Chief of Police, John McKeown reported that the Emergency Operations Plan for the Township has been approved by the County and State; it has been several years since we took over updating the old plan and he thanked everybody who had a part in working with the Township, such as Public Works, the school system, the fire companies and EMS to get this plan done in a timely manner and have a valid and reliable plan to safeguard the residents of the Township.

Cncl. Pres. DiLucia wished Engineer Kathryn Cornforth well with the birth of her baby and asked that she update us after the arrival of her baby.

F.) GENERAL PUBLIC DISCUSSION

Cncl. Miller made a motion to open the General Public Discussion. The motion was seconded by **Cncl. Marino** and unanimously approved by all members of Council in attendance.

Jennifer Lewis-Gallagher approached and addressed Council about signage within the Township. She referred to Ordinance O:24-90, which was in reference to the section entitled "Time limit for display of sign." in the Code of the Township of Monroe Chapter 243 Signs. She read aloud the first line of Section 243-2: "No sign, defined by this chapter, shall be permitted to

be displayed on public or private property within the Township of Monroe more than 30 days prior to the event or election of candidacy which is the subject of the particular sign.” She also read aloud the Code’s definition of ‘sign’: “Any form of printed outdoor advertising, such as a billboard, poster, bumper sticker or yard sign, made of any material, including but not limited to wood, cardboard, masonite, plastic and the like.” She spoke in reference to four billboards within the Township that display political campaign advertisement and asked Council if they knew when they became public and why they are posted in the Township. She believes they are related to a Primary Election, which is June 5, 2018, so her understanding, according to the Code, the date for posting would be May 6, 2018. **Cncl. Pres. DiLucia** addressed Mrs. Lewis-Gallagher, since his name is prominently displayed on these billboards that she was referring to, stating he believes it is lawful to do it on a sign; he recommended that she present it to the Solicitor, if she has evidence otherwise and he will rule on it. Mrs. Lewis-Gallagher replied that she had just read the Ordinance. **Cncl. Pres. DiLucia** reiterated that he said it is legally allowable and would not have put it up, if it was not. He believes those signs are legally there, whether they were his or someone else, they are allowed to be there, they have always been there for elections, both parties have done it in the past and they are doing it now. He does not think the Ordinance refers to political billboards, to which she replied that she read aloud the definition which included billboards. He said that his interpretation is that billboards are allowed and that she should seek legal recourse. Mrs. Lewis-Gallagher asked **Cncl. Pres. DiLucia** if she could ask Council for a legal response in regard to the interpretation of this Ordinance. He said that he would allow the Solicitor to respond. **Solicitor Boraske** replied that he will review the current Ordinance and respond back to Mrs. Lewis-Gallagher, adding that the Zoning Board can also do interpretations of their own Ordinances, so if she had a question about a particular aspect of the Land Use Ordinance that relates to certain types of billboards or the definition as used in the Ordinance, that is something that can be applied to the Land Use Board for an interpretation. She confirmed that if there can be any further legal review or interpretation as permissible by her request, she did include her name and phone number for contact and will also approach Director of Code Enforcement, Rosemary Flaherty in reference to this matter. **Mr. Boraske** said she can prepare an application and go before the Land Use Board for interpretation as an option. Mrs. Lewis-Gallagher asked when would be an appropriate follow-up for any legal interpretation. **Mr. Boraske** replied that he will review the current Ordinance and the issues that she raised, and will advise Council as to the Solicitor’s thoughts and if it can be discussed at a later meeting, she can return and be updated on the interpretation or the Township can communicate with her directly. Mrs. Lewis-Gallagher thanked him for the response.

Sue Pontano – 327 Oak Street said she spoke to **Dir. of Parks & Recreation, Jim Bonder** a month earlier about trees at the ball park that need to be cut down. She said **Mr. Bonder** did not do anything about the trees and said he would get back to her. She called the Mayor’s Office today and **Sherri McIlvaine** returned her call asking for her address. **Ms. Pontano** expressed her feelings about people, ball players and their parents, urinating in her yard. She stated that she needs a fence. She said if he (**Mr. Bonder**) has \$10,000.00 to put up signs at Owens Park, then a fence can be put up. She said that every time there are baseball games, she is the one cleaning up the trash and she is tired of it. **Dir. of Parks & Recreation, Jim Bonder** replied to **Ms. Pontano**, mentioning that due to the recent storms the past few months in the Tri-State area, trees are down in many areas and they are not yet caught up with cleaning it up. **Ms. Pontano** said this tree she spoke to him about, asking him to cut it down because it is from the Township’s property and hanging over on her property, has been dead for a long time. She said that if her grandchildren get hurt out there, there will be a big lawsuit. **Mr. Bonder** said that when he received the phone call today, he called **Dir. of Public Works, Mike Calvello** and they are both going to go out and take a look at it, do a survey and make sure the tree is on Township property. **Ms. Pontano** said she has the survey. He said if and when they can get to it, as soon as possible, they will. She asked about a fence. **Mr. Bonder** said he has addressed this with the organization and has been told that if someone is in fact urinating, her first response should be to ask them not to do it and then call the police. **Ms. Pontano** asked why she should tie-up the police when they can be out doing something else instead of the police coming out there every time someone comes on her property. She has put “No Trespassing” signs up and they rip them down. She said she cannot take pictures of these people urinating in her yard, because she would go to jail. **Mr. Bonder** said he would like to apologize, but cannot apologize for the people being

ignorant. In response to Ms. Pontano's request for a fence, he said that if you buy a property that backs up to a ballfield, it is "buyer beware"; if she would like to put up a fence, they are more than (*inaudible*). Ms. Pontano said she bought her home through a low/moderate income and cannot afford a fence, asking why they couldn't put a piece of fence up for her when they were putting up other fences. Mr. Bonder said that if they did that for her, they would have to do the same for everybody else. She asked "who is everybody", that she sees what goes on in the ballfield with him and his employees. **Cncl. Pres. DiLucia** asked Ms. Pontano to try to not get personal, to try to keep the conversation on point, that in terms to what Mr. Bonder does or does not do on the ballfield is inappropriate. He understands her problem and frustration, but asked for her to stay reasonable. Ms. Pontano explained her frustration, that people allow their children to pull her tree branches down and she gets into arguments with people who tell her that she never should have moved there, they curse at her, and she is fed up with it. Mr. Bonder agreed that it is disrespectful and understands because there are people who do the same with our parks and disregard the maintenance they do. He said the ballfield she is speaking about is the Minor League Ballfield, they moved the viewing area to the 3rd base side so that they are not in her area and the players only sit there in the dugouts, the fans should be on the 3rd base side and should not be encroaching on her area. She said they were out there tonight, two girls were climbing in the tree and the day before during a game, two boys were urinating in the tree. Mr. Bonder mentioned opening more bathrooms over there and will send an email out the next day to the president to correspond to all the parents and let them know this is unacceptable, to please stay off her area and if they can possibly delegate somebody to police the area for the next couple of weeks. She also mentioned that she thought dogs are not supposed to be out there, but people bring their dogs to the ballgames. She said there used to be a sign posted about dogs not being allowed. Mr. Bonder replied saying they cannot control what people do, they keep them off the fields and if they do see them, they ask them to leave, especially on the Church Street fields. He said he will send a message out to the president of the organization in reference to the dogs, asking them to respect her property. Mr. Bonder said there is a benefit to living close to a ballfield, especially if you have kids that are young because it is a convenience for them, but as your kids get older and you are not involved, it becomes a burden; he understands and respects that and reiterated that he will send an email out to the president of the organization. Mr. Bonder mentioned the posted sign that reads "Respect Our Facility and Honor the Game" and this is what they are trying to communicate to people. **Cncl. Pres. DiLucia** clarified that Mr. Bonder will go out to Ms. Pontano's property the next day to try to alleviate the problem with the tree, and in reference to the problem with urination, Ms. Pontano will have to call the police and continue to call them until they make arrests and teach the children that they will not get away with it.

Brandee Derieux – 43 N. Garwood Avenue questioned Council about the many new businesses the Township has opening, asking how many of these new businesses are really new businesses and are bringing tax revenue into the town or are they replacement businesses for businesses that failed. **Mayor Teefy** said there is a mix, a lot of them are businesses that have replaced previous businesses or were vacant properties that are now being occupied instead of being vacant. Ms. Derieux asked if we are bringing businesses in that are being tax deductible or are we bringing businesses in that are paying back taxes. The Mayor clarified they are businesses that are paying taxes, our revenue, and Businesses Administrator, Kevin Heydel mentioned with this tax revaluation, commercial property taxes went up \$9 million dollars. Ms. Derieux asked if this counts for churches who are non-taxable, to which the Mayor said no and she then asked how many churches we have coming up. The Mayor said he did not know of any new churches that we have coming up and Ms. Derieux asked if we have new daycares opening, which he replied there is St. Matthew's Baptist Church Daycare opening. She asked if there are other new businesses other than what we have now, asking about Main Street and what is going on with it and if we are still building it up with businesses. Mayor Teefy said that we are still working toward building up Main Street and thinks someone is interested in going in where Votta's Pharmacy and Cakes & Cookies Food Mart used to be. He thinks getting the Redevelopment Zone done by Council would help and give us a tool to work with some of the landlords that are not up to par with keeping up with their properties. Ms. Derieux asked about speed bumps. She asked if one road has one, why another road can't have one. Mayor Teefy explained that years ago, they were being put in, but Public Safety and the Road Department said

they are not good for emergency vehicles to be driving over in a hurry, because they slow them down and cause wear and tear on the vehicles. He thinks enforcement is better than speed bumps. Ms. Derieux lives near the Board of Education building and she can watch people speeding up and down that road. She stated that Church Street has bumps and her road does not. She has a special needs child and has spoken to Mr. Dilks and said she would pay for them to be installed, if she has to, because she needs them there. She wants to know how she can get safety for her child in that area. The Mayor pointed out that the Chief of Police was writing information down as she spoke and said what we need to have to do is put more enforcement on Garwood. She said signs have been put up, and the Mayor said tickets should be written to speeders.

Cncl. Miller made a motion to close the General Public Discussion. The motion was seconded by **Cncl. Marino** and unanimously approved by all members of Council in attendance.

CLOSED EXECUTIVE SESSION

Solicitor Boraske reported that Council just concluded a Closed Executive Session for the purpose of discussing pending litigation matters; Council was updated, but no formal action was taken.


G.) ADJOURNMENT
