Discussion: for Board Action:

1. #13-02 – Harold Paul Kanady – Certificate of Non-Conformity

Present – Harold Paul Kanady, applicant, John Makowski, applicant's attorney.

Member's packets contained: 1. A copy of the applicant's application, letters and photographs marked as exhibits. 2. Evidence presented by the applicant in the form of receipts, a tax certificate, and a letter. 3. Evidence and photographs submitted by Bunny Bouchard.

The applicant is asking for a Certificate of Non-Conformity so that he can continue to repair the trucks he uses for his business on the property located at 1887 York Avenue, also known as Block 15403, Lot 12.
