Business Administrator Kevin Heydel reported our new twenty-passenger van, which also has areas for two wheelchairs, was delivered. The van will be utilized for the township bus program and will replace the 2001 bus. The van was purchased through a co-operative agreement between Gloucester County and the municipality for a total cost of \$74,000.00. The municipality's share was \$37,000.00.
