1. #14-06 – Harold Paul Kanady – Use Variance

The applicant is seeking a use variance in order to be allowed to utilize his existing pole barn/garage on Lot 12 to perform vehicle repairs on his personal trucks he uses for his business, H. Paul Kanady Trucking, which is located on Lot 13. The applicant was granted a Certificate of Nonconformity on May 7, 2013 permitting limited truck repair of his own trucks. The property is located on York Avenue, also known as Block 15403, Lot 12 in the R-3 Zoning District.
