

**MINUTES
SENIORS COMMISSION

The Regular Meeting of the Monroe Township Seniors Commission was called to order by Chairperson Jeanette Remsen at 7:00pm in the 2nd Floor Meeting Room of the Municipal Complex. Notice of this meeting was given as required by the annual notice of meetings.

CORRESPONDENCE, REPORTS AND OTHER MATTERS

Jeanette Remsen noted that there were only 35 people on the August trip. Empty seats may need to be paid for, but she's not sure yet. There were 49 people on the July trip. The September trip to Hunterdon Hills Playhouse for 'Social Security' will be on September 22nd, with 35 people so far; if they don't get 41 people, they may have to pay for empty seats. The October trip to American Music Theatre for 'Inspire' will be on October 7th, eating at Fulton Steamboat, costing \$61.00. Sight and Sound Theater for 'Samson' is booked for May 10, 2016. Jeanette said that she would like to book a Christmas show for November to American Music Theatre and a Christmas show for December to Hunterdon Hills Playhouse. After some discussion with the members in attendance, Jeanette will try to book 'The 2015 Christmas Show: Deck the Halls' at American Music, eating at Hershey Farms, for November 10th, and 'A Branson Country Christmas 2015' at Hunterdon Hills Playhouse for December 11th.

Jeanette mentioned the Blood Drive held on August 17th. She said it was not a good attendance. Calls were made and 52 appointments were made, but 33 people didn't show. The goal was to collect 42 pints of blood; 21 pints were donated, which would possible help 87 people, per the Red Cross.
