# F.) GENERAL PUBLIC DISCUSSION

**Cncl. DiLucia** made a motion to open the General Public Discussion. The motion was seconded by **Cncl. Marino** and unanimously approved by all members of Council.

Matt Mills, 64 Washington Avenue, noted the Ambulance Association met with the Mayor approximately a week ago to review the numbers regarding the Rescue responses for 2016. Initially the Ambulance Association was told the rescue truck was moved because of the numbers but by the end of our discussion it was not about numbers anymore. We are appealing to the Council to review the numbers with us since we are trying to find out what the root cause of this was because it seems to have changed. Cncl. Miller commented as far as Council is concerned it is the Mayor's decision because he has the authority to determine where equipment is placed. Appealing to Council is really not going to change it unless the Mayor's opinion is changed. Mr. Mills noted he just wanted to know what the actual root cause of the move was and if there is a

possibility for more discussion about this because what we were told and what was in the letter we received is not the same thing. Cncl. Pres., McIlvaine recommended discussion on this be held at the next meeting when the Mayor is present because ultimately the decision is his. He added he supported and still supports the Mayor's decision. He spoke of attending the meeting but since he left about half way through didn't know what was said after he left and doesn't want to guess what the Mayor was thinking. Cncl. DiLucia noted he was not at that meeting but had suggested it be held due to Mr. Mills' contending at a previous Council Meeting that the numbers were incorrect. This meeting was supposed to exchange factual numbers in terms of response time and he questioned whether that was done. Mr. Mills explained basically what happened was that he had a copy of the papers he thought the Mayor had used to make the initial decision and he brought with him additional information and asked the Mayor to show him what the discrepancies were that caused him to make the move because the letter the Association received said it had to do with response times. He noted he thought that once they went over the calls and the correct information was addressed that perhaps the Mayor would realize a mistake had been made and a different decision would be reached but that didn't happen. After reviewing all the information the Mayor stuck to his same decision and said we will know if a mistake was Mr. Mills noted he felt that the Association made after six months if we receive complaints. didn't get a fair shake in presenting their case because it seems the decision was set in stone before the meeting even though we had numbers that didn't match up with what we were told. Cncl. DiLucia noted he was under the impression that the decision was made because there was a contention public safety was being jeopardized from a lack of expedient response time. He questioned whether that was also Mr. Mills' understanding and whether he was disputing the accuracy of the information that was given to the Mayor. Mr. Mills replied yes. Cncl. DiLucia questioned if the information Mr. Mills presented to the Mayor was what he believed to be the accurate times and if so where did that information come from. Mr. Mills replied from the Ambulance Association reports but mainly from looking through the actual reports from Gloucester County dispatch not just the summary. Cncl. DiLucia questioned whether the figures Mr. Mills had could be verified and whether the records were accurate. Mr. Mills explained the figures can be verified only through the dispatch times. Records for the most part are accurate but at times human error is involved and County dispatch has input incorrect times for locations throughout the County when they are super busy. Mr. Mills noted the Mayor had received a summary from the County but we actually looked at the emails from County to get more details about every call in 2016 but specifically the calls the Mayor contended were the problems. Cncl. DiLucia questioned whether there was anything that Mr. Mills could identify that was specifically disputed between their numbers and the numbers the Mayor had. Mr. Mills explained during the first meeting when the truck was taken the papers the Mayor had were summaries but at the second meeting he had updated information from the County that was a more detailed account. Those numbers reflected a better outcome than what Mayor Teefy had initially thought and the cause he had initially quoted us during the first meeting. Mr. Mills explained at the request of Mayor Teefy he forwarded to Council spread sheet of reports from each call, which crews are required to complete along with those done by Gloucester County so we don't understand why the truck was not moved back. Cncl. DiLucia questioned whether they were given an explanation. Mr. Mills replied "what's done is done" is basically what was said and that in six months if there are no complaints we will know there was no mistake. He added he felt he made a strong argument that it would be in the best interest of public safety to move the truck back based on the numbers he presented as well as on the Ambulance Association training compared to the Fire Department's training. He also argued that if draw upon a pool of twenty people from one station and twenty from the other station you could wind up with a solid number responding but now the number of people the township paid to train who have years of experience has been cut in half and that makes no sense. Cncl. DiLucia agreed with Cncl. McIlvaine that the only way to have intelligent dialogue is to have the Mayor here to speak for himself but he just wanted to Mr. Mills questioned when the Mayor is at the next get Mr. Mills take on what transpired. meeting will there be some discussion on this. Cncl. DiLucia noted he is only one person but he thinks there should be some type of discussion since the contention was the truck was moved because public safety was jeopardized and if those numbers were inaccurate then he would assume the right thing would be done. Mr. Mills noted he would like to present numbers and a solid argument so a decision could be made based on the welfare of the township. He felt instead of cutting the foot off one of the township volunteer emergency services departments that all departments could work together. Cncl. Marino noted Mr. Mills used the number of 40 volunteers and he questioned whether that was 20 with the fire department and 20

with EMS and if they work together would that mean the truck would stay housed where it is. He added he feels both agencies should work together. Mr. Mills noted when the truck was moved to the fire department we were told our rescue squad would no longer do rescue services. Mr. Mills reviewed the training records for both departments and showed the Mayor the numbers from each department and the rescue training they had in each specific discipline. He explained previously when there was a rescue call the rescue squad and the fire department would respond and we would work together but we were told we were no longer allowed to have anything to do with rescue services in town so our department no longer responds so now when the pager Cncl. Marino questioned goes off you are no longer drawing from a pool of forty people. whether the two department chiefs got together to discuss ways to get the other twenty volunteers involved in rescue and if not could they do that. Mr. Mills noted they did not sit down because we were told by the Mayor we would not be involved anymore. Mr. Mills noted it is difficult because these are two different departments and if someone has ten years as a member of the Ambulance Association they don't want to resign to join the other organization. Cncl. Marino questioned if the twenty people work rescue only. Mr. Mills noted twenty is a hypothetical number but we do have people who only work rescue that will be leaving the department since there is nothing for them to do. Cncl. DiLucia noted he was not clear on who told them they could not work together. Mr. Mills stated the Mayor said we can't work together. When we had the truck we worked with the fire department but now that the truck is at the fire department we have nothing to do with rescue in town and since we are no longer dispatched to those call the volunteers are being drawn from a smaller pool. The only way for members of our association to participate in rescue is if they quit our association and join the fire department, which would mean they would stop running ambulance calls and lose the time they put into our association. Mr. Mills noted that is not something he could do, as he attends college, works full time and as a volunteer dedicates a lot of time to the ambulance squad so it is not feasible for him to go through that entire process and there are a lot of other people in the same situation. He added he does not understand why the people the township paid to train to do rescue and who have experience are no longer able to come out and participate in rescue. Cncl. DiLucia questioned what Mr. Mills' suggestion was on how this would work. Mr. Mills noted it worked before when we had our trucks. We worked closely with the fire department by participating in training. Cncl. DiLucia noted if the rescue truck stays with the fire department and a rescue is dispatched could the ambulance members go in an ambulance and help with the rescue, as that would be a joint effort. Mr. Mills noted it would be difficult because there are members of the rescue squad that are not EMTs and to move an ambulance you need two EMTs. Another issue is specialized training. Cncl. Marino questioned whether in Mr. Mills opinion there was no reason to move the truck. Mr. Mills noted the reason that was presented was very vague. Now that argument has been taken off the table, which is where the confusion comes in because we were told the numbers don't matter anymore so what is the real reason. Cncl. Marino questioned how many people from the fire department went through rescue training. Mr. Mills noted that depends on what discipline of rescue we are talking about, as the rescue team was responsible for several different types of rescue. There is extrication, water and elevator rescue as well as other types of rescue and our department is trained in every discipline of rescue that we are responsible for. He noted he hates to speak for another department but after reviewing the fire department's records they are not trained in water, ice or trench rescue. Cncl. Marino questioned Mr. Mills noted the fire how many firemen have training in the other disciplines of rescue. department has 28 people trained in extrication based off of the training records that were provided to him. Cncl. Marino noted it is hard for him to make a decision if he does not know how many people are cross trained in rescue and fire. Cncl. Pres., McIlvaine noted this issue will be discussed during the next Work Session Meeting when the Mayor is in attendance and he will ask the chief of the Williamstown Fire Department and the Monroe Township Ambulance Association to attend to answer questions on behalf of their personnel. He felt discussing this when the Mayor is not here is a moot point because we are only getting one side of the story so he will be glad to entertain whatever they have to say at the next Work Session Meeting. Mr. Mills noted he understands and his goal is just to have the departments work together for the benefit of public safety and he is willing to attend the next Work Session to address his concerns. Cncl. Pres., McIlvaine promised to give the Ambulance Association the time they need out of respect for the service they provide to Monroe Township.

**Cncl. Garbowski** made a motion to close the General Public Discussion. The motion was seconded by **Cncl. Marino** and unanimously approved by all members of Council.
