PUBLIC PORTION: There were no public present.

VICKI MACHULSKY:

COUNCILMAN WALT BRYSON: Cncl. Bryson reminded the members of the British Car Show on Main Street on May 21st.

JEN TOAL: Jen asked who she would ask if Chickens were permitted at the corner of Kali Lane & Winslow Road and also about Bamboo on the property. Dan said that Zoning would handle the chickens and Vicki said that she would send out a notice for bamboo since that was an ordinance now in effect.

RENE PANDOLA: Rene reported the house next to the bike path on Fries Mill Road. Dan said he would look into it.

BARBARA CHAMBERLAIN: Barbara said that her and Eileen attended the Arts Festival with Monroe Township and Gloucester County Board of Health information, but also reported that they did not have much traffic. Gloucester County BOH info included Safewell, Stagnant water and dog count complaints. Barbara also brought up that she was curious if the Mayor was a part of the NJ Mayors Wellness Campaign, and that she has not received a response about if the town is involved or not. The Mayor came in to the meeting at a little while later and Barbara was able to ask him in person. He sad that the Township is not but he would like to look into it and see if this would be beneficial for the Township.

- Corner of Broadlane Road & Winslow Road Dan said that this was worked on at the Township Clean Communities Day (He was part of the group that did it)
- Former Lic D Split Zoning Officer, Rosemary Flaherty, is getting some progress on this property by new owners. Still needs some work but removed the overgrowth on the building.
- Grass on North Main Street (1100-1400) Dan, Vicki and Tara reported that both BOH and Vacant housing are working on them.
