C.) PUBLIC PORTION

Cncl. McIlvaine made a motion to open the Public Portion. The motion was seconded by Cncl. Marino and unanimously approved by all members of Council in attendance.

Joe Fisona - 19 Gibson Lane approached council members to advise them that "Sunny Estates" has formed a civic association, it is composed of some **190 homes thus far and he introduced Rich Schmidt as the Vice-President, with Mr. Fisona being named President. Mr. Fisona then reported on the intersection at Rt. 42 & Cross Keys Road advising he received an email from the Senator's office stating there was good news to report as he had just learned that the improvement work was approved by the NJDOT Review Board and it is to be included in the State Department of Transportation Improvement Project. He then spoke on a 25% cost sharing commitment from the municipality and he questioned if the Mayor had received anything on this. Mayor Teefy advised he did speak with a lady from the state and they are looking to include this when they do the timing of the light at that location. Mr. Fisona mentioned that this year the right-of-way and the design has been approved and construction will be done in 2019. He received a cost estimate from the Office of Community and Construction Constituent Relations that indicated an estimate of the work to be somewhere in the area of \$20,000 -\$30,000. Mr. Fisona then advised a public hearing will be held in Washington Township sometime in June. Mayor Teefy then noted that he felt the petition that Mr. Fisona generated and sent to the state was a great help in securing the funding, etc. Cncl. McIlvaine expressed his thanks to Mr. Fisona for all his efforts with respect to this project.

Cncl. McIlvaine made a motion to close the Public Portion. The motion was seconded by Cncl. Marino and unanimously approved by all members of Council in attendance.

D.) <u>NEW BUSINESS</u>

Cncl. McIlvaine noted he just met with the Williamstown Fire Chief and he handed me the proposal for the new rescue pumper that was talked about in the capital improvement budget. Initially, the price was to be around \$720,000.00 and it looks like it is coming in at \$698,641.00. He questioned if we would going through a co-op for the purchase. Business Administrator, Kevin Heydel posed some questions with respect to the purchase, one being the name of the company we are buying from. Cncl. McIlvaine noted he would like to see this done as he was advised there was a 260-270 day turnaround before they would receive the truck. Mayor Teefy advised the chief is going to look at the pld vehicle to see if it could be used as a trade-on versus selling it on the open market. Cncl. Pres., DiLucia questioned if there were any bids on that. Cncl. McIlvaine advised there is just the one figure and it is going with a co-op, there is no bid process as he understands. Mr. Heydel noted that was correct but what you are supposed to be showing is a savings of what it would be without going through the co-op, against what it is going through the co-op. He advised he could get those figures. Mr. Heydel stressed this is an easier way to purchase a vehicle but you still have to provide and show that there is a savings as this is a requirement.

He added we did an advertisement today for the ambulance remount with the same H-GAC co-op (Houston-Galveston Area Council). The savings could include such items as the cost of advertising, bid bonds to be placed, etc. Cncl. Pres., DiLucia questioned if Mr. Heydel was confident that by getting a price from the same company we are buying it from, that it would be acceptable. Mr. Heydel responded yes, because what would happen is then you would have to take the full bid specs to someone else and have them price out and chances are you won't have the same bid specs because there are different manufacturers Discussion continued on the rescue pumper and the various options.

Mr. Heydel indicated you could still award the contracts this evening.
