

**MINUTES
SENIORS COMMISSION
TOWNSHIP OF MONROE
JANUARY 10, 2019**

CORRESPONDENCE, REPORTS AND OTHER MATTERS

Secretary Aileen provided a copy of Resolution SC/R:01-19 in the matter of the Seniors Commission 2019 Meeting Dates. Aileen asked for a motion to approve Resolution SC/R:01-19. Jeanette Remsen made a motion, seconded by Ginny Kramer and unanimously all in favor by all members of the Commission.

The members discussed 2019 trips. The January trip is to the Tropicana Casino to see ‘Oldies But Goodies’. The February trip is on Valentine’s Day to Academy of Culinary Arts to eat dinner at Careme’s Restaurant. The March trip is to Sight & Sound Theatres to see ‘Jesus’. Jeanette asked Marita if she received information for Dover Downs Races. Marita is in the process of contacting and receiving information. Jeanette informed the members that ‘Queen Esther’ will be showing at Sight & Sounds Theatres in 2020. She was told by the bus company that the best thing to do is to book the show now. The Commission members agreed.

Jeanette informed the members that there is a blood drive scheduled for February 8, 2019. She asked which member would like to help with the blood drive. Rachel and Marita will help to make phone calls for donation appointments. The Commission’s goal is to have 19 pints of blood donated.

Jeanette discussed with the members about collecting money for the bus driver when signing-in people.

Ginny asked where the bus is departing from for the January trip. Jeanette said they are departing from the Pfeiffer Community Center. She also said they cannot leave from the Holiday City Clubhouse for certain trips, because the new buses are bigger and where they have to park, it is impossible to load a wheelchair onto it.

Jeanette explained to James, the newest Commission member, about the requirement of the medical form that each person going on a Township trip needs to fill-out and hand-in to her.

Jeanette said she does not yet know what the Commission's budget is for 2019. She was told the Commission will be receiving an extra \$1,000 in the 2019 budget, however, she does not know if this will come to fruition.

Ginny Kramer made a motion to adjourn the Monroe Township Seniors Commission Reorganization Meeting of January 10, 2019.
