The Mayor clarified that this does not mean that the residents will not incur a tax increase, because there is also the entities of the school board and the County, which the Mayor and Council have no control over.

**Director of Public Works, Nicholas Mercado** reported the E-Waste Shred Event was a huge success. They collected 2.66 tons of paper and a truck and a half full of other components to be weighed. Public Works will be scheduling another event for later in September. The recycling flyers were printed and given to the MUA to include with their June billing distribution. He congratulated
