

Firearms Permits and Registration

Effective 10/1/20 after you are approved for permits they will be electronically emailed to you after your fee is paid to the MTPD

The Monroe Township Police Department - Records Division assists residents with the application, processing and registration of firearms. The firearms application process is now electronic (everything is done on-line). Please follow the below instructions for the Firearms Reporting System.

FARS Application Procedures for Applicants

****First time applicants can contact the Records Division for additional information and assistance regarding the process****

Step 1: visit the website. You **MUST** enter the site address as follows:

Step 2: When you log on, you **MUST** enter the Monroe Township Police Department's ORI # **NJ0081100**

Step 3: Complete the online application. You may complete the application using a smartphone, mobile device, laptop or desktop computer. **You can upload a copy of your drivers license and employment verification (paystub).** If not, it must be submitted to the police department before anything will be issued. You must have a Firearms Identification Card in order to purchase any gun or ammunition.

When deciding how many permits you would like to get, remember:

- a. ONE permit is required for each handgun you wish to purchase (each permit is \$2) and will be issued electronically. No exceptions.
- b. You can only purchase 1 handgun in a 30-day period
- c. Permits are good for up to 180 days (with renewal after 90 days)
- d. If you decide you want another handgun permit and you didn't get more than one initially, you will need to apply again. No exceptions – This is a state rule.

Step 4: If employed, please provide proof of employment. Proof may be a recent paystub or a letter from your employer. If submitting a paystub, you can black out the information regarding your salary. **This can be submitted via email, fax, mail or in person with your date of submission and confirmation number written/typed on it.**

Step 5: You will need to submit payment at the Police department for your permits and, if applicable, the Firearms ID card. Permits to purchase handguns are \$2 for each permit, and \$5 for the ID card, which needs to be paid by cash, check or money order made payable to the Monroe Township Police Department. We do not accept credit/debit cards.

- You will be receiving automated email updates throughout this process.
- Once your application is complete, a Monroe Township Police Records employee will contact you to retrieve your Firearms ID card and/or Pistol Permit documents.
- Please advise your references that the FARS system will email them the reference questions to be answered. Your references can complete the questions using a smartphone, mobile device, laptop or desktop computer. Please advise them to complete the questions immediately to progress your background investigation.
- The on-line application is applicant driven. Please ensure that you have entered the best phone numbers for yourself and references as well as the best email address for yourself and your references.

Common Errors:

You must have or apply for a firearms identification card before you can apply for any permits.

Date of Birth – Please make sure you are 21 before applying for a permit to purchase a handgun.

Address – Please make sure you are a resident of MONROE TOWNSHIP (Williamstown) and your drivers license has your current address. If not please change it with DMV prior to applying.

References – Please use a valid email address for your references.

Please make sure you request permits when applying for a Firearms ID Card if you wanted permits. They can no longer be added on if you forgot. You must reapply and start the process over.

Gun Shopping – It is strongly suggested to apply for permits before shopping for a gun, this process takes approximately 3 months from the date of submission to obtain a card and/or permit. Calling us to expedite your application will not occur.
