BARBARA WINKLESPECT: stated that she was informed that you need to be affiliated with an association and you will be provided with T-shirts, garbage gloves and garbage bags. There was a discussion about her concerns with trash, littering, community clean up and boy scout troops. VICKI informed her that most of her concerns were not handled by the Board of Health and that she could contact Jackie Wallace in the OEM office for Community Clean up and Public Works for trash removal and street sweepers. Vicki went on to explain the basic function and responsibility of the Board of Health in the Township.
