APPROVAL OF MINUTES:

VICKI MACHULSKY: Stated that she reached out to the Vet in reference to the Rabies Clinic and she said she would still do the clinic, we are planning the clinic for January 23, 2020 from 12:00pm to 2:00pm. Vicki said she reached out to OEM, the Clerk's Office, The Mayor's office and Administration just to let them know if that had any comments and if it was ok to still hold the Rabies Clinic.

VICKI MACHULSKY: Stated that **DAVID SCALES** had asked her about the TNR program and she said she reached out to Elisa Taylor who is the person running it and she also reached out to Animal Control. She said she also reached out to Jules Maiorano who is the HALO for the Township. She said Animal control and Jules both stated that they have not had any complaints about the TNR program. **DAVID SCALES** asked if there were any colonies approved, Vicki said it was just a Trap Neuter and Release program only. There was a discussion about this topic. Vicki is going to look further into the TNR program.

VICKI MACHULSKY: Stated that there was a complaint about dogs barking at a house last week. Animal Control went out with Jules Maiorano, dogs were not licensed, they informed them about the complaint. They went back out again this week and the dogs are healthy and in the back yard. They explained the situation about the barking and told Vicki that they try to educate before they violate.

VICKI MACHULSKY: Announced that we have a new seafood place opening called the Sea Bar on Main Street. They will be serving cooked seafood and right now they have to get a new vent put in above the stove. All other papers have been done.

DAN KOZAK: Nothing to report.

BEN JONES: Stated that there is a property that use to be quality furniture and it was sold to a developer and the property is a disgrace. There is also a house on the right on 322 past the Wawa. He believes it was the house that a car went through years ago and they were working on it and all the work seems to have stopped. He said he was going to try to get the addresses.
