**WHEREAS**, *N.J.S.A. 40A:4-19* provides that temporary appropriations should be made for the amount of such Debt Service in the manner and time provided.

**NOW, THEREFORE, BE IT RESOLVED** that the temporary appropriations attached as “**Schedule A**” be made and that a certified copy of this resolution be transmitted to the Chief Financial Officer.
