

**RESOLUTION R:39-2022**

**RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING LOCAL SUPPORT FOR TRIPLE G HOLDINGS CORPORATION FOR ITS CLASS 1 CANNABIS CULTIVATOR LICENSE AND CLASS 2 CANNABIS MANUFACTURER LICENSE APPLICATIONS TO THE NEW JERSEY CANNABIS REGULATORY COMMISSION**

**WHEREAS**, in 2020, New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called “cannabis” for adults at least 21 years of age; and

**WHEREAS**, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act” (the “Act”), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

**WHEREAS**, the Act establishes six marketplace classes of licensed businesses, including Class 1 Cannabis Cultivator License, for facilities involved in growing and cultivating cannabis and Class 2 Cannabis Manufacturer License, to produce recreational use cannabis products; and

**WHEREAS**, in accordance with the regulations established by the Act, N.J.A.C. 17:30-5.1, an applicant for an annual cannabis business license shall include proof of local support in their applications, which shall be submitted as a resolution adopted by the governing body.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council for the Township of Monroe that the Township of Monroe hereby supports the applicant, Triple G Holdings Corporation, for the type of cannabis business licenses being sought to operate within the Township of Monroe’s jurisdiction in accordance with Chapter §175-163.4 of the Township Code of the Township of Monroe.
