Refunds

\$2,425.82 to be refunded to Corelogic for Block 14401.02, Lot 40, for overpayment of taxes for Totally Disable Veteran.

\$69.22 to be refunded to Block 8801, Lot 6, Marion Massaro for overpayment of taxes.

Cancellations

Joseph J Rigilano, property owner at 3777 Dorchester Drive, Block 8001.04, Lot 9, is a 100% totally disabled veteran and the Gloucester County Tax Assessor has approved the property tax exemption effective December 15, 2021. Taxes in the amount of \$117.00 for the year 2021 will be canceled and in the amount of \$935.72 for the year 2022 will be canceled. A refund for \$117.00 to homeowner will be processed.

Ramon L Souchet, property owner at 79 Burr Street, Block 14401.03, Lot 50 is a 100% totally disabled veteran and the Gloucester County Tax Assessor has approved the property tax exemption effective November 23, 2021. Taxes in the amount of \$125.06 for the year 2021 will be canceled and in the amount of \$471.51 for the year 2022 will be canceled. A refund for \$125.06 to homeowner will be processed.

Taxes in the amount of \$749.76 for the year 2021 will be canceled and in the amount of \$6,127.81 for the year 2022 will be canceled. A refund for \$749.76 to homeowner will be processed.
