**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE  
DESIGNATING THE APPOINTMENT OF A RECORDS CUSTODIAN AT THE  
MONROE TOWNSHIP LIBRARY FOR THE PURPOSES OF  
OPEN PUBLIC RECORDS AND LITIGATION MATTERS**

**WHEREAS**, the Township Council of the Township of Monroe recognizes that requests for records pursuant to subpoenas and the Open Public Records Act (“OPRA”) must be acted upon within established time periods; and

**WHEREAS**, the Township Council of the Township of Monroe also recognizes that N.J.S.A. 47:1A et seq. places the responsibility of OPRA responses on the Municipal Clerk; and

**WHEREAS**, the Township Council of the Township of Monroe is aware that the Township receives numerous requests for records pursuant to OPRA; and

**WHEREAS**, in an effort to expeditiously and accurately respond to OPRA requests, and in accordance with the applicable rules and statutes governing same, the Township Council of the Township of Monroe shall designate Karen Uhl, Custodian of Records for the Monroe Township Library; and

**WHEREAS**, the Monroe Township Library Records Custodian shall be deputized by the Municipal Clerk to be solely responsible for the OPRA requests issued to the Monroe Township Library; and

**WHEREAS**, the Township Council of the Township of Monroe has determined that the designation of a Monroe Township Library Records Custodian is in the best interest of the Township.

**NOW, THEREFORE BE IT RESOLVED** by the Township Council of the Township of Monroe hereby designate Karen Uhl as the Records Custodian of the Monroe Township Library.

**BE IT FURTHER RESOLVED** that the Monroe Township Library Records Custodian shall be responsible for complying with OPRA requests and/or appearances served upon the Monroe Township Library.

**BE IT FURTHER RESOLVED** that this resolution shall take effect immediately.
