

**RESOLUTION R:50-2022**

**RESOLUTION AUTHORIZING THE TOWNSHIP OF MONROE TO ENTER INTO A CONTRACT WITH KEITH BONCHI, ESQUIRE TO PROVIDE PROFESSIONAL LEGAL SERVICES FOR THE HANDLING OF FORECLOSURES ON BEHALF OF THE TOWNSHIP OF MONROE FOR THE YEAR 2022**

**WHEREAS**, a need exists for professional legal services for the handling of *in rem* and *in personam* foreclosures on behalf of the Township of Monroe, County of Gloucester, State of New Jersey for the year 2022; and

**WHEREAS**, the Local Public Contracts Law N.J.S.A. 40A:11, et seq. requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids must be advertised; and

**WHEREAS**, this contract is awarded in accordance with the Fair and Open procedures as established in the "Pay to Play" Law N.J.S.A. 19:44A-20.5 et seq.; and

**WHEREAS**, the Township Council of the Township of Monroe hereby authorizes the Township of Monroe to enter into a Contract for services as set forth in the Contract.

**WHEREAS**, the Mayor of the Township of Monroe has submitted the appointment of **KEITH BONCHI, ESQUIRE**, said contract attached hereto and made a part hereof, same being submitted to the Township of Monroe to enter into such agreement; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Monroe, County of Gloucester and State of New Jersey that:

1. The Mayor is authorized to sign a contract with **KEITH BONCHI, ESQUIRE**, 660 New Road, First Floor, Northfield, NJ 08225, on behalf of the Township of Monroe, contingent upon the review and approval of the Township Solicitor.
2. The contract period shall be from January 1, 2022 to December 31, 2022 not to exceed \$30,000.00.
3. The Chief Financial Officer has certified that sufficient funds are available in the budget account number 2-01-20-160-160-327, entitled Legal Fees-Foreclosure/Appeals/ Abatement, contingent upon the availability of sufficient funds and the adoption of the temporary or final budget for 2022.
4. Notice of the contract award shall be published in one of the official newspapers for the Township of Monroe.
