**RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING A CONTRACT
WITH THE GLOUCESTER, SALEM, CUMBERLAND COUNTIES MUNICIPAL
JOINT INSURANCE FUND RETROSPECTIVE PROGRAM**

WHEREAS, the Gloucester, Salem, Cumberland Counties Joint Insurance Fund (FUND) has offered to the Township of Monroe (known hereafter as MEMBER) a policy endorsement to enter into a Retrospective Program for the 2022 Fund Year with the understanding that a Retrospective Assessment may be due and owing to the FUND through December 31, 2026; and

WHEREAS, this program affords MEMBER the opportunity, through improved performance, to control their future assessments in accordance with the formulas set forth in the Contract and the Policy Endorsement; and

WHEREAS, the contract term shall commence on January 1, 2022 and end on June 30, 2027.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe that it does hereby authorize the Township to enter into a contract with the Gloucester, Salem, Cumberland Counties Joint Insurance Fund for the 2022 Retrospective Program and further authorizes the Mayor and the Township Clerk to execute same.
