

**RESOLUTION R:62-2022**

**EMERGENCY TEMPORARY RESOLUTION PRIOR TO ADOPTION OF THE 2022 BUDGET FOR THE TOWNSHIP OF MONROE, COUNTY OF GLOUCESTER**

1. An Emergency Temporary Appropriation be and the same is hereby made for the appropriation of emergency temporary funds until final adoption of the budget, and that said Emergency Temporary Appropriation will be provided for in the 2022 Budget under title of:
