**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE
AUTHORIZING THE TOWNSHIP OF MONROE TO ENTER INTO A CONTRACT
WITH THE PETTIT GROUP, LLC FOR
ENGINEERING AND ARCHITECTURAL SERVICES FOR
THE REHABILITATION OF THE OWENS PARK HOCKEY RINKS**

WHEREAS, a need exists for professional engineering and architectural services for the rehabilitation of Owens Park Hockey Rinks in the Township of Monroe, County of Gloucester, State of New Jersey for the year 2022; and

WHEREAS, the Local Public Contracts Law N.J.S.A. 40A:11, et seq. requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids must be advertised; and

WHEREAS, this contract is awarded in accordance with the Fair and Open procedures as established in the "Pay to Play" Law N.J.S.A. 19:44A-20.5 et seq.; and

WHEREAS, the Township Council of the Township of Monroe hereby authorizes the Township of Monroe to enter into a Contract for services as set forth in the Contract.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester and State of New Jersey that:

1. The Mayor is authorized to sign a contract with **THE PETTIT GROUP, LLC**, 497 Center Street, Sewell NJ 08080, on behalf of the Township of Monroe, to provide professional engineering and architectural services for the rehabilitation of Owens Park Hockey Rinks.
2. The contract period shall be from February 24, 2022 to December 31, 2022, not to exceed \$24,500.00.
3. The Chief Financial Officer has certified that sufficient funds are available in the budget account number T-03-56-193-000-001, entitled Reserve for Open Space Trust, contingent upon the availability of sufficient funds and the adoption of the temporary or final budget for 2022.
4. Notice of the contract award shall be published in one of the official newspapers for the Township of Monroe.
