**Refunds**

\$2,753.51 to be refunded to Corelogic for Block 22.0202, Lot 10, for overpayment of taxes.

**Cancellations**

William J Smith, property owner at 524 Key West Drive, Block 9.0202, Lot 7, is a 100% totally disabled veteran and the Gloucester County Tax Assessor has approved the property tax exemption effective February 9, 2022. Taxes in the amount of \$2,207.18 for the year 2022 will be canceled and a refund in the amount of \$778.09 to Corelogic will be processed.
