**WHEREAS**, the Township Council of the Township of Monroe agree with the Side Letter Agreement.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey, that the Mayor is hereby authorized to execute the Side Letter Agreement between UFCW Local 360 and the Township of Monroe.
