

RESOLUTION R:94-2022

RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING AN AWARD OF CONTRACT TO COMMAND CO. INC. FOR THE MONROE TOWNSHIP DOG PARK

WHEREAS, the Township of Monroe and the Township’s Engineers have determined that there is a need for the acquisition of the following goods and services:

MONROE TOWNSHIP DOG PARK; and

WHEREAS, a notice of advertisement for bids and an Invitation to Bid were prepared and advertised in accordance with the Local Public Contracts Law; and

WHEREAS, sealed bids were opened and read on March 2, 2022 at 10:00 am in accordance with the requirements of the Local Public Contracts and Public Notice posted in the required newspaper and on the Township’s website; and

WHEREAS, four (4) bids were received as follows:

Command Co., Inc.	\$794,373.00 (\$888,934.70 base bid plus all Add Alternates)
Fred M. Schiavone Construction, Inc.	\$1,052,913.95 (\$1,200,286.35 base bid plus all Add Alternates)
Think Pavers Hardscaping, LLC	\$1,270,297.00 (\$1,432,872.00 base bid plus all Add Alternates)
JCP Group, Inc.	\$1,526,604.72 (\$1,695,039.72 base bid plus all Add Alternates)

WHEREAS, the Township Engineer has reviewed the bids and recommend that the award of the contract for the Monroe Township Dog Park Bid, plus Add Alternates 1, 2, 3 and 6, be made to Command Co., Inc. in the amount of \$888,934.70 as the lowest responsible bidder; and

WHEREAS, the Township Engineer and Solicitor have reviewed the bid proposal package and documents submitted by the lowest responsible bidder, declares them to be in conformance with the Township instructions to the Bidders and the Local Public Contracts Law and recommends an award of contract to Command Co., Inc. as the lowest responsible bidder; and

WHEREAS, the funds are available for that purpose; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey, that for the reasons set forth hereinabove;

1. An award of contract for the Monroe Township Dog Park is hereby made to Command Co., Inc. as the lowest responsible bidder in the amount of \$888,934.70.
2. The Mayor and Township Clerk are hereby authorized to execute the Township standard form of Contract subject to review and approval by the Solicitor as well as any related documents.
