DEBRA VALCOURT-SHERMAN: Asked who she should contact about Juniper Village and 2 residents passing away a day or so after they were given the COVID Vaccine there. Debra also mentioned that she noticed the employees at the Amish Market were wearing mesh masks. Vicki said she would contact the owner in reference to this matter.

RENE PANDOLA: Stated that the Amish Market employees are not being COVID complaint especially the counter that sells chicken fresh meats and the counter that sells the bacon. Vicki said she will call the business owner and look into it.

SHERRIE KENNEDY: Asked if Burger King has to have restrooms that are in working order? She was in the drive-thru and there were signs posted that the bathrooms were out of order. Vicki stated that she would look into it

DIANA SALVADORI: Reported that the property behind the Barber shop on Rail Road Avenue has a pile of trash and old wood in front of it. She stated it looks like someone left a trash bin there and the trash just keeps growing.

DAVID SCALES: Nothing to report.

RONALD GARBOWSKI: Not present.

DAVID SCALES: With no further business to discuss, **DAVID SCALES** asked for a motion to adjourn and **RENE PANDOLA** made a motion to adjourn the Monroe Township Board of Health meeting of February 10, 2021 the motion was seconded by **MARIE SHERIDAN**.
