APPROVAL OF MINUTES:

DIANA SALVADORI made a motion to approve the minutes from the March 10th, 2021 meeting of the Monroe Township Board of Health. The motion was seconded **SHERRIE KENNEDY**. All members agreed to approving the minutes.

DAVID SCALES: The total cash settlement for March of 2021 was \$3,737.00.

REPORTS:

CHARLOTTE RUDOLPH: Stated that we did hold the Rabies Clinic on March 13, 2021. We gave out vaccinations to 111 dogs and 19 cats.

CHARLOTTE RUDOLPH: Spoke to Sherri from the Board of Health Office she said there really has not been any complaints other than dogs not being leashed and owners not picking of their dog's waste.

DIANA SALVADORI: Nothing to report.

DAN KOZAK: Stated that he spoke to the homeowner on Ripley in reference to the Large dogs that run to the end of the property unleashed. Dan said they do have an electric dog fence and it does not have to be posted. He was not around for the rabies shots he is waiting for his appointment with his regular Vet so he can get his dogs licensed. Dan stated that unless the Ordinance Committee decides to make an ordinance requiring that when you have an electric fence you need to post it, it does not need to be posted. Marie thanked Dan and said now at least she knows there is an electric fence.

RENE PANDOLA: Nothing to report but she had a question in reference to construction that is going on right on Fries Mill Road near the bike path they are clearing away a bunch of stuff and there is a concrete slab. Ron Garbowksi responded and said it is a parking area. The concrete is for handicapped persons. Rene stated it did not look big enough to be a parking spot. There was a brief discussion in reference to this matter. Rene also stated that there were some old structures on the adjacent property that need to be addressed.

MARIE SHERIDAN: Nothing to report.

SHERRIE KENNEDY: Stated that she went by Rail Road Avenue properties and it looks like everything is cleaned up, there wasn't anything in front of the donation boxes. Dan Kozak commented that Tara Parks is taking her to court. There was a discussion about this property. She also mentioned there was some complaints about the bulk trash that is near the houses behind the 13th Child Brewery. Dan said that is a clean out and Public Works has to address that.

DEBRA VALCOURT-SHERMAN: Stated that she did see that there was a lot of things posted about needles on the street on Library and she stated that she noticed there were two (2) needles on the street on Winslow Road. She asked what we would do in that case. There was a discussion in reference to this. She also stated that the Amish Market employees are not wearing masks again.

RONALD GARBOWSKI: Nothing to report. He said he heard about the Amish Market people not wearing masks again. Ron also stated that if needles are on the Public roadways public works can pick them up.

DAVID SCALES: Nothing to report.
