APPROVAL OF MINUTES:

RENE PANDOLA made a motion to approve the minutes from the October 13th, 2021 meeting of the Monroe Township Board of Health. The motion was seconded **DAN KOZAK**. All members agreed to approving the minutes.

DIANA SALVADORI: The total cash settlement for October of 2021 was \$4,664.78

REPORTS:

CHARLOTTE RUDOLPH: Stated that Vicki wanted her to inform the Board that we will have Ann McGinley coming to the December meeting in reference to a dog variance. Ann purchased a home at 1722 Biden Lane, she is moving to our town from Magnolia and has four (4) dogs, ages are eleven (11) 2 of them are eight (8) and one is six (6). All members stated that everyone saw it except Rene. There was a discussion about this matter.

CHARLOTTE RUDOLPH: Stated that Vicki also wanted her to let them know that she has the Solicitor looking over the Amendment to the Tattoo Ordinance to include body art which will include body make up like eyebrows, lipstick etc. She said body art is regulated by the state and its under their tattoo law and it will be on the agenda for next year.

DIANA SALVADORI: Asked the board if we wanted to discuss Ann McGinley and her dogs now or wait for her presentation. **CHARLOTTE** stated that it was probably better to wait for the presentation because **RENE** was not able to look over the email **VICKI** sent out. **SHERRI** asked if the email could also be sent to her.

CHARLOTTE RUDOLPH: Stated that the only other thing she had to make the Board aware of is that **JULES MAIRANO** the Townships Humane Law Enforcement Officer wanted me to clarify what he should be contacted for. He is only to be contacted for Animal Cruelty. Any other complaints should go to Zoning or Animal Control. There was a discussion about this matter.

RENE PANDOLA: Stated that she still has the three issues she reported last meeting. She stated that in the meeting minutes she noticed that **DAN KOZAK** stated that he needed the actual address for the house that had the Bamboo. She stated that the mailbox and house does not have any numbers on it. She said it was directly across from the Wawa and there are two properties that run together and then they run back to the landscaper's property. She stated that it was tied up keeping it close together but is still there. She also stated that it is still overgrown on the house on the corner of Fries Mill and 322 and now there is tons of construction going on there. There is curbing and stuff going on and it's hazardous with all of those trees and stuff overgrown. She also stated that again she is complaining about the asphalt company she said the smell is horrendous. She stated that all the years she has lived there they never experienced the smell being that bad. She said they just drove by it today and it took your breath away. She said that she doesn't know what they are doing different or if there is anything that can be done about it but if she lived any closer to it she doesn't know what she would do. She can't imagine what it is like for the residents that are living near it.

DAN KOZAK: Stated that he reviewed the paperwork that **VICKI** sent to the board in reference to Ann McGinley. He said that she just purchased the home and there weren't any complaints as far as he knows from the neighbors and the yard is fenced in. He said he is apprehensive in making her go through all the expenses of a variance with the ages of the dogs and her being a new resident. He feels that she went about handling the whole situation correctly. He stated that he would like to suggest that we waive the variance for now, inform her that if one dog passes it can not be replaced. He also stated that she would need to provide up to date shot records and that 3 of the 4 dogs would need to be licensed and as long as there are no issues or complaints we would have to move forward with the variance. There was a discussion about this and the members agreed to waive the variance with the above stated stipulations.
