

ORDINANCE O:08-2022

**AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE
AUTHORIZING THE ACCEPTANCE OF REAL PROPERTY KNOWN AND
DESIGNATED AS TAX BLOCK 3205, PORTION OF LOT 3 ON THE TAX AND
ASSESSMENT MAP OF THE TOWNSHIP OF MONROE**

WHEREAS, pursuant to *N.J.S.A. 40A:12-1 et. seq.* a municipality may acquire any real property for public use; and

WHEREAS, Newfield National Bank is the owner of property located at 320 South Main Street, Williamstown, New Jersey also known as Block 3205, Lot 3 on the Tax Map; and

WHEREAS, the Township of Monroe is in the process of acquiring the adjacent property known as Block 3205, Lot 28 on the Tax Map; and

WHEREAS, Newfield National Bank is donating the back portion of its Lot 3 to the Township of Monroe; and

WHEREAS, the Township of Monroe and Newfield National Bank wish to enter into the attached Contract for Real Estate wherein Newfield National Bank agrees to donate the back portion of Lot 3 to the Township; and

WHEREAS, as part of the land donation, the Township of Monroe will make application to the Planning/Zoning Board for the proposed Minor Subdivision of Block 3205, Lot 3; and

WHEREAS, the Township of Monroe has determined that the aforementioned real property is needed for public use; and

WHEREAS, the Township of Monroe seeks to acquire a portion of the real property known and designated as Block 3205, portion of Lot 3 on the Tax and Assessment Map in accordance with *N.J.S.A. 40A:12-1 et. seq.*

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey as follows:

SECTION I. The Township of Monroe authorizes the acceptance of the real property known and designated as Tax Block 3205, portion of Lot 3 on the Tax and Assessment Map of the Township of Monroe in accordance with the provisions of the Local Lands and Buildings Law Pursuant to *N.J.S.A. 40A:12-1 et. seq.*

SECTION II. The Township of Monroe authorizes the Township Solicitor, Township Engineer, and such other Township officials as are necessary to obtain such appraisals as are necessary to ascertain the fair market value of the aforesaid real property to be acquired.

SECTION III. The Township of Monroe authorizes the attached Contract for Real Estate subject to final review and approval by the Township Solicitor and to negotiate its terms in accordance with applicable law and to do and to perform all other acts as are necessary to complete the real estate transaction including retaining such professionals including, but not limited to, such engineers, land surveyors, title company and the like.

SECTION VI. All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION VII. This Ordinance shall take effect in accordance with all applicable laws.
