RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING THE MAYOR OF THE TOWNSHIP OF MONROE TO ENTER INTO DEVELOPER'S AGREEMENT BETWEEN THE TOWNSHIP OF MONROE AND RICHARD SCHMIDT CONCERNING REAL PROPERTY IDENTIFIED AS BLOCK 5601, LOT 22

WHEREAS, Richard Schmidt is the owner of the Property located at 3208 S. Black Horse Pike, Block 5601, Lot 22 as identified on the Tax Map for the Township of Monroe which is located in the RD-C Rural Development Commercial District and is within the New Jersey Pinelands; and

WHEREAS, pursuant to Planning Board Resolution PB-13-2020, the Board granted preliminary and final major site plan approval with variances and waivers to develop an off-road rider training and education facility and associated site improvements for all terrain vehicles/motorcycle safety training (the "Project") subject to all the conditions set forth in said Resolution; and

WHEREAS, the nature and the extent of the aforesaid Project is set forth in the Resolution Number PB-13-2020 (dated 7/23/2020) of the Township of Monroe Planning Board; and

WHEREAS, the Developer is required to enter into a Developer's Agreement with the Township of Monroe setting forth the rights, duties and obligations of the parties in connection with the Development; and

WHEREAS, there has been prepared a Developer's Agreement by and between the Developer and the Township of Monroe attached hereto; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe as follows:

1. The Mayor of the Township of Monroe be authorized to enter into and execute the Developer's Agreement subject to review and final approval of the Township Solicitor subsequent to the execution by the Developer and together with other appropriate officers and employees of the Township are here by authorized to take all steps necessary effectuate the purposes of this Resolution.
2. The Township hereby authorizes and approves any non-substantive modification to the Developer's Agreement as may be recommended and approved by the Township Engineer and Township Solicitor prior to execution.
3. This Resolution shall take effect immediately.
