

RESOLUTION R:104-2022

**RESOLUTION AUTHORIZING CLOSED EXECUTIVE SESSION OF THE
TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE**

WHEREAS, the Township Council of the Township of Monroe is subject to the requirements of the Open Public Meeting Act *N.J.S.A. 10:4-6 et seq.*; and

WHEREAS, the Open Public Meetings Act of the State of New Jersey generally requires that all meetings of public bodies be open to the public; and

WHEREAS, the Open Public Meetings Act further provides that a public body may exclude the public from a portion of a meeting at which time the public body discusses items enumerated in the Open Public Meetings Act at *N.J.S.A. 10:4-12b*, which items are recognized as requiring confidentiality; and

WHEREAS, it is necessary and appropriate for the Township Council of the Township of Monroe to discuss certain matters in a meeting not open to the public consistent with *N.J.S.A. 10:4-12b*.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, pursuant to the Open Public Meetings Act of the State of New Jersey, as follows:

- 1.) The Township Council shall hold a closed meeting from which the public shall be excluded on April 6, 2022.
- 2.) The general nature of the subjects to be discussed at said closed meeting shall be related to *N.J.S.A. 10:4-12(b)(7)*, potential litigation relating to ProChamps and vacant property registration.
- 3.) The minutes of said closed meeting shall be made available for disclosure to the public consistent with *N.J.S.A. 10:4-13*, when the items which are subject of the closed session discussion are resolved and a reason for confidentiality no longer exists.
