RESOLUTION APPROVING THE 2022 GLOUCESTER COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT PUBLIC FACILITY AND INFRASTRUCTURE PROJECTS APPLICATION FOR CONSTRUCTION OF SIDEWALKS AND ADA CURB RAMPS AT VARIOUS LOCATIONS WITHIN THE TOWNSHIP OF MONROE, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY

WHEREAS, the Township of Monroe desires to construct new sidewalks and ADA curb ramps at the following intersections: W. Lois Drive and Fern Road, W. Lois Drive and Kirk Road, E. Lois Drive and Fern Road, and E. Lois Drive and Kirk Road; and

WHEREAS, the Township of Monroe wishes to apply for fund for said project in the amount of **\$50,000.00** through the Gloucester County Community Development Block Grant Program (CDBG); and

WHEREAS, in furtherance of the same, it is necessary for the Township Council of the Township of Monroe to authorize the accompanying application, Application ID: 30335, to allow the Township to be eligible for a sum in the amount of **\$50,000.00** for Construction of Sidewalks and ADA Curb Ramps; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe that the Mayor is hereby authorized to submit the attached application requesting funding in the amount of **\$50,000.00** from the 2022 Gloucester County Community Development Block Grant (CDBG) Public Facility and Infrastructure projects (PF&I) for the project entitled "Construction of Sidewalks and ADA Curb Ramps".
