**RESOLUTION OF THE TOWNSHIP OF MONROE AUTHORIZING
THE REDUCTION OF AN IRREVOCABLE STANDBY LETTER OF CREDIT FOR
THE GREENS #1854, PHASE 1 (BLOCK 14801, LOT 12)**

WHEREAS, the Developer of the Site known as The Greens (Phase 1, Block 14801, Lot 12) had originally posted with the Township a Performance Guarantee in the form of an Irrevocable Standby Letter of Credit No. #2857-A issued by Parke Bank in the amount of \$1,681,110.00 for certain site improvements and approved by Township Council of the Township of Monroe by Resolution R:147-2021 on July 26, 2021; and

WHEREAS, the Developer has requested a reduction of said Performance Guarantee; and

WHEREAS, Pennoni Associates, Inc., Township Engineer on the Project, by correspondence dated May 19, 2022, indicates that the project has been inspected and recommends that the performance guarantee in the form of surety bond in the amount of \$1,681,110.00 be reduced as follows:

Bonded Aspect	Original Amount	Reduced Performance Guarantee
Phase 1	\$1,681,110.00	\$550,586.40

WHEREAS, this reduction should be conditioned upon payment of all outstanding charges against any and all escrow accounts associated with this project; and

WHEREAS, the Township of Monroe agrees with said recommendation.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Council of the Township of Monroe, County of Gloucester and State of New Jersey on this 27th day of June 2022, that:

1. The above-referenced Performance Guarantee be reduced as stated conditioned upon payment of all outstanding charges against any and all escrow accounts associated with this project.
2. The Township Clerk is directed to forward a certified copy of this Resolution to the Township Engineer, Township Solicitor and Hovbros Greens, LLC.
