

**RESOLUTION R:142-2022**

**RESOLUTION OF THE TOWNSHIP OF MONROE  
AUTHORIZING A CHANGE ORDER FOR A CONTRACT WITH  
COMMAND CO., INC. FOR THE MONROE TOWNSHIP DOG PARK**

**WHEREAS**, Resolution R:94-2022, approved on March 14, 2022, awarded a contract to Command Co., Inc. (contractor) for the Monroe Township Dog Park for a total contract amount of \$888,934.70; and

**WHEREAS**, after the award, it was determined that the Monroe Municipal Utilities Authority (MMUA) will be performing all watermain work for the project listed under Bid Alternate No. 6; and

**WHEREAS**, the contractor has agreed to relinquish Bid Alternate No. 6 work in favor of the MMUA and deduct the amount from the original contract total; and

**WHEREAS**, it is necessary to amend the aforementioned contract as outlined in the attached Changer Order Number 01; and

**WHEREAS**, the amount to be deducted from the total contract is \$48,805.00 representing a -5.49% change in the contract; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Monroe, as follows:

1. A change order in the amount of \$48,805.00 decreasing the total contract amount with Command Co., Inc. from \$888,934.70 to \$840,129.70 is hereby approved; and
2. The Township Clerk is directed to forward a certified copy of this Resolution to the Chief Financial Officer, Township Engineer, Pennoni, Township Solicitor and Command Co., Inc.
