

**RESOLUTION R:167-2022**

**RESOLUTION OF THE TOWNSHIP OF MONROE  
REJECTING ALL BIDS FOR  
WILLIAMSTOWN FIRE STATION DEMOLITION PROJECT**

**WHEREAS**, the Township of Monroe authorized the receipt of bids for the Williamstown Fire Station Demolition Project; and

**WHEREAS**, six (6) sealed bids were received and opened on May 10, 2022; and

**WHEREAS**, said bids were as follows:

1. Brennan Brothers Contracting, LLC - \$79,515.00
2. Neri's Construction & Rentals, Inc. - \$79,500.00
3. Richard E. Pierson Construction Co., Inc. - \$120,140.00
4. Two Brothers Contracting, Inc. - \$364,950.00
5. W. Hargrove Demolition Co., Inc. - \$89,210.00
6. Winzinger, Inc. - \$123,000.00

**WHEREAS**, the lowest bid substantially exceeds the cost estimates for the goods or services; and

**WHEREAS**, *N.J.S.A. 40A:11-13.2* states said rejection is just cause to reject all bids received for the Williamstown Fire Station Demolition Project; and

**WHEREAS**, it is the desire of Township of Monroe to reject all bids received on May 10, 2022 for exceeding the cost estimate; and

**WHEREAS**, the Township Council of the Township of Monroe hereby determines that it is in the best interest of the Township to reject all bids; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Monroe as follows:

1. It hereby rejects all bids received for the Williamstown Fire Station Demolition Project for the reasons set forth in this Resolution.
2. It requires certified copies of this Resolution to be provided by the Township Clerk to each of the following: Brennan Brothers Contracting, LLC; Neri's Construction & Rentals, Inc.; Richard E. Pierson Construction Co., Inc.; Two Brothers Contracting, Inc.; W. Hargrove Demolition Co., Inc.; and Winzinger, Inc.
