**WHEREAS**, N.J.S.A. 52:34-6.2(b)(3) authorizes contracting units to purchase goods, or to contract for services, may make purchases and contract for services through the use of a nationally-recognized and accepted cooperative purchasing agreement that has been developed utilizing a competitive bidding process by another contracting unit within the State of New Jersey, or within any other state, when available; and

**WHEREAS**, Sourcewell is a nationally recognized and accepted cooperative purchasing contracting unit within the State of Minnesota that utilizes a competitive bid or competitive proposal process in awarding contracts for goods and services and is authorized by Minnesota law to extend its contracts to local government units nationwide; and

**WHEREAS**, the Township of Monroe intends to participate under a National Cooperative Purchasing Agreement, Sourcewell, for the purpose of purchasing two (2) Labrie 33 (31+2) Cu. Yd R/H Automizer Automated Refuse Collection System Mounted on a 2021 Autocar Model ACX64 Chassis 66,000lb GVW; and

**WHEREAS**, GranTurk Equipment Co., Inc., One Schuylkill Parkway, Building B, Bridgeport, PA 19405, local distributor for Labrie Enviroquip, and Industrial Truck, were awarded the contract with Sourcewell under Contract #091219-LEG and Contract #060920-ATC; and

**WHEREAS**, it is the intent of the Township of Monroe to make a contract award to GranTurk Equipment Co., Inc. pursuant to the proposal submitted to Sourcewell; and

**WHEREAS**, the Sourcewell Contract #091219-LEG shall terminate November 15, 2023; and

**WHEREAS**, the Sourcewell Contract #060920-ATC shall terminate August 1, 2024; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Monroe, County of Gloucester, and State of New Jersey as follows:

1. That the governing body does hereby approve the purchase with GranTurk Equipment Co., Inc., local distributor for Labrie Enviroquip, and Industrial Truck, 1015 S. 50<sup>th</sup> Street, Tampa, FL 36619, through Sourcewell, Contract #091219-LEG and Contract #060920-ATC, in the total aggregate amount of \$720,838.40.
