

**RESOLUTION R:32-2023**

**RESOLUTION OF REAPPOINTMENT OF LORRAINE BOYER TO THE POSITION  
OF CHIEF FINANCIAL OFFICER OF THE TOWNSHIP OF MONROE,  
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY**

**WHEREAS**, pursuant to Resolution R:52-2019, Lorraine Boyer was appointed Chief Financial Officer of the Township of Monroe for a term of four (4) years commencing on January 1, 2019 through December 31, 2022; and

**WHEREAS**, N.J.S.A. 40A:9-140.10 requires that “in every municipality there shall be a Chief Financial Officer appointed by the governing body of the municipality”; and

**WHEREAS**, N.J.S.A. 40A:9-140.10 further states that the term of the Chief Financial Officer “shall be four years, which shall run from January 1 in the year in which the Chief Financial Officer is appointed”; and

**WHEREAS**, the Township of Monroe is in need of a Chief Financial Officer and the Township Council of the Township of Monroe desires to reappoint Lorraine Boyer as Chief Financial Officer; and

**WHEREAS**, upon reappointment, Lorraine Boyer shall be eligible to obtain tenure as a Chief Financial Officer pursuant to the requirements of N.J.S.A. 40A:9-140.13 and other relevant statutes; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey as follows:

1. Lorraine Boyer is hereby reappointed to the position of Chief Financial Officer of the Township of Monroe.
2. Lorraine Boyer shall be eligible to obtain tenure pursuant to the requirements of N.J.S.A. 40A:9-140.13 and other relevant statutes.
3. A copy of the resolution be forwarded to the Chief Financial Officer, Administrator, Township Clerk, and the Director of the Department of Local Government Services for their records.
