### **Ordinance for Board Action:**

1. Ordinance – O:04-2023 – Hexa Redevelopment Plan

Ms. Galella explained to the Board that the plan was presented tonight for Master Plan consistency review. She stated that the Ordinance was introduced by Council to the Board for approval. The redevelopment plan involves property in the Pinelands and the Pinelands Commission asked for amendments to the plan involving development credits. Mr. Hunt from Alaimo had prepared a report that stated the amendment is consistent with the Master Plan.

Present is Ms. Emily Givens, attorney for the Hexa developer. Ms. Givens stated that he ordinance was adopted last year by Council. Ms. Givens explained that the changes to the plan were made to appease the Pinelands Commission; as the plan changed and took away the residential portion the Pinelands required that the development credits still be satisfied. Mr. Brown asked Ms. Givens where the project was located. Ms. Givens replied she only had the Block and Lot to reference. Mr. Wolfe replied the property is south bound on the Pike. Ms. Orbaczewski explained an old project called Cedar Creek that never happened, that is the property in question. Ms. Givens also pointed out that the project will have to come back for site plan approval.
