

RESOLUTION R:69-2023

RESOLUTION AUTHORIZING THE EXECUTION OF CHANGE ORDER NO. 1 FOR SOUTH STATE, INC. IN THE DECREASED AMOUNT OF \$13,065.30 FOR SERVICES ASSOCIATED WITH THE NJDOT FY 2021 MUNICIPAL AID WHISPERING WOODS PROJECT IN THE TOWNSHIP OF MONROE, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY

WHEREAS, pursuant to Resolution R:184-2021, the Township of Monroe accepted the bid and entered into a contract with **South State, Inc.** for services associated with the NJDOT FY 2021 Municipal Aid Whispering Woods Project; and

WHEREAS, the Township Engineer on the project, Pennoni Associates, has recommended Change Order No. 1 for the contract MTSPX20302, known as the NJDOT FY 2021 Municipal Aid Whispering Woods Project, pursuant to their letter dated January 23, 2023; and

WHEREAS, the Change Order is for the final as-built quantities and core testing penalty; and

WHEREAS, the original contract amount is **\$268,418.30**; and

WHEREAS, the Change Order is decreasing the amount of the contract by **\$13,065.30**; and

WHEREAS, the revisions to the prior contract and a change order is necessary in order to complete the project in the most efficient and cost-effective manner for all of the residents of the Township of Monroe.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Monroe, County of Gloucester, and State of New Jersey that the contractor's contract is hereby amended to include a decrease in the amount of **\$13,065.30** for services and hereby approves and authorizes the execution of Change Oder No. 1 in the new amount of **\$255,353.00**.
