**RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT
WITH THE MONROE TOWNSHIP BOARD OF EDUCATION FOR
SCHOOL RESOURCE OFFICER SERVICES FOR THE 2022-2023 SCHOOL YEAR**

WHEREAS, the Township of Monroe (“Township”) operates a Police Department within the Township; and

WHEREAS, the Monroe Township Board of Education (“Board”) operates elementary and secondary schools (collectively, “Schools”) within the Township; and

WHEREAS, the Board and the Township recognize the benefit of a School Resource Officer Program to the citizens of the Township and the students, staff and parents of the Monroe Township School District in reducing juvenile delinquency through a collaborative approach between law enforcement and the Board that focuses on education, prevention, communication and information sharing; and

WHEREAS, it is in the best interest of the Township and the Board to establish and maintain the School Resource Officer Program at schools; and

WHEREAS, the Board and the Township desire to provide the services of one (1) full-time officer and one (1) SLEO III to Williamstown High School, two (2) SLEO III’s to Williamstown Middle School and four (4) SLEO III’s to the four (4) elementary schools to provide School Resource Officer services for the 2022-2023 school year; and

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of Monroe, County of Gloucester, State of New Jersey, does hereby authorize the Mayor to execute an Agreement with the Monroe Township Board of Education to participate in an Agreement for the School Resource Officer, said agreement attached hereto.
